A pre-race swab sample was taken from Don Knee. Jenny Love Heart underwent a post-race veterinary examination and minor abrasions were detected to the left foreleg. No Stand down period was applied. Stewards spoke to Trainer representative, Mrs S Gittus in relation to Jenny Love Heart's racing manners approaching the home turn and in the home turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Jenny Love Heart turned its head inwards on two occasions, and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR124. Acting under the provisions of GAR127(a), Jenny Love Heart has been stood down from racing for a period of 28 days Devonport at Hobart only and until the completion of a satisfactory trial.

#### **GENERAL:**

Tricked It completed a Stewards satisfactory trial as it was stood down from the Hobart Greyhound Racing Club meeting on the 21/07/2022 for failing to pursue by reason of injury pursuant to GAR125(1). Weighing 33.6 kilograms and beginning from box 1, Tricked It completed the 461-metre trial distance in a time of 27.75. Tricked It was unsatisfactory after easing in the back straight and failing to pursue the lure with due commitment.

Dirty Feet Again completed a Stewards satisfactory weight trial. Weighing 33.3 kilograms and beginning from box 3, Dirty Feet Again completed the 461-metre trial distance in a time of 28.45. Dirty Feet Again was unsatisfactory after easing in the home straight and failing to pursue the lure with due commitment. A post-race swab sample was taken from Dirty Feet Again.

Dark Summer completed a Stewards satisfactory trial as it was stood down from the Sandown Park Greyhound Racing Club meeting on the 21/02/2022 for marring and to seek approval to wear blinkers in future events pursuant to GAR123 and GAR91(1) respectively. Weighing 31.6 kilograms and beginning from box 5, Dark Summer completed the 461-metre trial distance in a time of 28.11. Dark Summer was unsatisfactory after easing on the first turn and failing to pursue the lure with due commitment.
