Comments / Explanations:

Stewards accepted the reasons for late rider declarations for todays meeting. B Neto was severely reprimanded under ARR 190(3) for accepting a ride for which he was found to be overweight.

RACE 1 – TASMANIAN WINE CENTRE CLASS 3 HCP (1430 METRES)

RAVAGE – raced wide throughout.

BELL RINGER BOY - inclined to lay in over the concluding stages.

Following this event, the track was downgraded to a Slow 6.

RACE 2 – LADBROKES PUNTER ASSIST MAIDEN (1430 METRES)

The start of the race was 3 delayed minutes due to UNNERVING undergoing a veterinary examination after becoming fractious when loaded into the barriers.

FRYER HILL – declared a late scratching at 10:30am after sustaining a head injury. Connections were advised that a veterinary clearance would be required prior to trialling

or racing. Stewards ordered all bets on Fryer Hill to be refunded in full with the following deductions:

- 1st Expensive Mistake 8c win 12c place
- 2nd Chi Mazel 5c place
- 3rd Multisanti 11c place

CHI MAZEL – lay in passing the 1100 metres; hung in and had to be continually straightened over the final 300 metres

GOOGA THE GOAT – placed in restricted room and had to steady approaching the winning post.

MULTISANTI – Shifted in abruptly near the 250 metres.

UNNERVING – underwent veterinary inspection and passed fit to run after becoming fractious in the barriers, a warning has been placed on the gelding's barrier manners. Raced greenly in the early and middle stages having to be continually restrained. Steadied near the 1100 metres when placed in restricted room when Chi Mazel commenced to over race and had to be restrained.

LEICA STARLET – got its head up and raced ungenerously in the lead during the early and middle stages. Checked near the 250 metres when Multisanti shifted in despite the efforts of the rider.

RACE 3 – LADBROKES MATES MODE MAIDEN (1430 METRES)

GEEGEESLOCKDOWN – crowded on jumping and settled back.

PRINCE OF PASSION – had to steady passing the 400 metres after being placed in restricted room when near the heels of DASHING KNIGHT which was tiring.

SPEED ROCK – bounded on jumping and lost ground.

VELOCE AQUILA – S Carr was questioned regarding the poor performance today however could offer no explanation.

RACE 4 – LADBROKES IT! MAIDEN (1200 METRES)

SUPERCRAFT – hung in from 400 metres and had to be continually straightened throughout the home straight.

TIMMY TWO SOX – held up for a short distance passing the 600 metres.

UPWARD AND ONWARD – raced wide throughout; hung in and had to be corrected passing the 200 metres.

HER THOUGHTS – was a late scratching on veterinary advice at 12:26pm after an eye injury was detected. Stewards ordered all bets to be refunded in full with the following deductions:

1st GEE GEE MISS QUITA 32c win 18c place
2nd UPWARD AND ONWARD 30c place
3rd WOUNDED MISS 30c place
SMASHING HIT – restrained and shifted out passing the 150 metres when UPWARD AND ONWARD shifted out and raced tightly to its inside.

I'M VERY HAPPY – had to be restrained off heels passing the 700 metres when racing fiercely.

STARCADIA – fractious during the preliminary, a warning placed on the filly's manners.

RACE 5 – JOCKEY CELEBRATION DAY 0-60 (1430 METRES)

CHOSEN EAGLE – T Baker reported that the gelding was unsuited by today's track conditions.

GEE GEE RHYTHM – carried wider over the concluding stages when NEED A FLUTTER shifted out.

HERMAN'S BELLS – inclined to lay in from the 250 metres.

RACE 6 – KEVIN SHARKIE MDN/CL1 (1600 METRES)

CYCLONE LOUIE – crowded after the start and steadied; held up briefly near the 400 metres. D Parrish was reminded of her obligation to ride her mounts fully to the line.

GEE GEE SPEEDY SKY – compounded in the home straight and finished to be beaten in excess of 23 lengths. N Punch reported the gelding failed to handle today's track conditions. A post-race veterinary examination revealed no obvious abnormality. Stewards will follow up with trainer L Wells.

POWERFUL PEBBLES – bounded on jumping and was slow to begin.

SMOKIN' HARD – D Pires reported that the mare had failed to back up from last week's run. A post-race veterinary examination revealed no obvious abnormality.

TOUGH COOKIE – T Johnstone accidently dropped her whip passing the 150 metres.

RAPID EFFECT – failed to muster early speed.

RACE 7 – IT'S WHY WE RACE BM68 HCP (1600 METRES)

IVORYMAN (NZ) – crowded after the start and lost ground.

RANSOM TRUST – over-raced in the lead.

GEE GEE SILENTNITE – began awkwardly and settled back.

SUNSET GUN – momentarily held up rounding the home turn.

RACE 8 – JOCKEY CELEBRATION DAY BM68 HCP (1200 METRES)

Rider B Neto was unable to make the allotted weight for ENTRAPPED and as trainer G McCulloch did not wish the mare to carry 1kg overweight N Punch was substituted.

Given all circumstances B Neto was issued with a severe reprimand under ARR 190(3) and reminded of his obligations when accepting his rides.

STELLADONI – bounded at the start and then crowded losing ground, held up briefly passing the 400 metres.

RACE 9 – ELWICK FUNCTIONS & EVENTS BM76 HCP (1100 METRES)

Correct weight was delayed when C Baker (THUNBERG 2nd place) requested to view the films of the home straight. After doing so she lodged a protest against the winner (JULIUS) alleging interference after entering the home straight. After considering submissions from the riders, trainer S Brunton and viewing the patrol films the protest was dismissed. It was established that THUNBERG had been carried wider entering the home straight by JULIUS shifting outwards, but the interference suffered was negligible.

JULIUS – shifted wider entering the home straight. Crowded over the concluding stages when THUNBERG shifted in marginally and raced tightly to its outside.

KUROSET – Tailed the field in the early stages. Stewards advised L Bingley she may have erred in not making more effort to make up ground.

JAJA CHABOOGIE – raced wide throughout.

THUNBERG – carried wider entering the home straight when JULIUS shifted outward.

RACE 10 – TASMANIAN BLOODSTOCK CLASS 1 HCP (1100 METRES)

FIGHTING STYX was declared a non-runner at 4:28pm after being denied a fair start as it was being held when the gates opened. Stewards ordered all bets to be refunded in full with the following deductions:

1st NEUTRALIZE 3c win 3c place2nd PUNK PRINCESS3rd TWEE4c place

Trainer Mr P Dargan was advised that FIGHTING STYX must trial to the satisfaction of the Stewards for being fractious in the barriers.

A post-race veterinary examination of FIGHTING STYX, which finished a considerable distance from the winner, revealed the mare to be displaying cardiac arrhythmia. Trainer P Dargan was advised that a veterinary clearance, including the results of an ECG, must be produced after a 1000 metre gallop prior to **FIGHTING STYX** trialling to the satisfaction of the Stewards.

TAPPA PASS – was momentarily tightened approaching the 200 metres

SIGNTHECHEQUE – hung in throughout. A post-race veterinary examination revealed mild reaction to digital pressure on the near fore pastern. A veterinary certificate of soundness will be required prior to trialling or racing.

Apprentice L Bingley was reminded of her obligations to ride her mounts fully to the line.
