Comments / Explanations:

Rider C Atkinson was indisposed for today's meeting due to a track work incident.

RACE 1 – LADBROKES MATES MODE MAIDEN - (1150 METRES)

ALPINE ASSAULT – Steadied off heels of GAYNIK approaching the 600 metres.

NO ACCESS – Bounded on jumping, steadied off the heels of GAYNIK approaching the 600 metres, laid in entering home the straight and shifted out when attempting to straighten.

PROPHET EYES – Jumped outwards at the start tightening BUEL out onto SHE DECIDES, raced fiercely in the early stages, shifted in over the concluding stages.

FASHION DESIGNER – Jumped awkwardly.

GAYNIK – Raced wide throughout.

SHE DECIDES – Lost ground on jumping when BUEL shifted out.

TENNESSEE BEACH – Over-raced in the middle stages of the race.

BORN A WINNER – Raced wide throughout.

BUEL – Tightened on jumping when PROPHET EYES shifted out onto PROPHET EYES and lost ground.

MISS VIVACE – Shifted out shortly after jumping tightening BUEL out onto SHE DECIDES.

RACE 2 – VALE PAMMY PEARCE MAIDEN - (1150 METRES)

BARBIE'S ACHEEVA – Over-raced early and middle stages, restrained off the heels of PUMA approaching the 600 metres.

SOUTHERN WIND – Raced wide throughout

GOES LIKE THE WIND – Over-raced throughout the middle stages.

PRINCESS MATOAKA – Raced wide throughout. Near the 800 metres restrained off the heels of QUICKEN UP and then commenced to over race and shift wider on the track.

SHE'S KAGEY – Tightened at the start when QUICKEN UP jumped inwards.

STATUE OF DREAMS – Was declared a late scratching at 11:35AM on veterinary advice, after rearing in the barriers and casting the near foreleg in the barriers. Statue Of Dreams must complete a satisfactory trial for its barrier manners prior to racing again. All monies invested on the mare were ordered to be refunded in full, with the following deductions.

1 st - Quicken Up	5 cents a win, 4 cents a place
2 nd - Princess Matoaka	9 cents a place
3 rd - Southern Wind	12 cents a place

QUICKEN UP – Shifted in on jumping tightening SHE'S KAGEY and SOUTHERN WIND, raced wide throughout.

RACE 3 – KEVIN SHARKIE MAIDEN - (1350 METRES)

FASHION FOX – Raced wide throughout, had a tendency to lay in, in the home straight, raced greenly throughout.

GEEGEELOCKDOWN – Slow to begin, over-raced in the early and middle stages.

GOOGA THE GOAT – Slow to begin, raced wide throughout.

HEWIE – Jumped awkwardly and was slow to begin as a result, shifted out abruptly soon after, raced fiercely in the early stages. Inclined to Lay in throughout the home straight. Stewards spoke to Rider T Doyle regarding his mount shifting approaching the 100 metres. Rider T Doyle was advised to exercise care in the future.

LACERATE – Stewards questioned Rider I Toker regarding the below market expectations of the gelding. Rider I Toker stated that the gelding failed to run out the distance and that the gelding made unusual respiratory noises. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

MULTISANTI – Over-raced in the early and middles stages

SPEED ROCK – Hung out throughout the race.

ST REGIS (NZ) – Steadied off the heels of SHAKEEDA approaching the 900 metres.

RACE 4 – GOODSTONE GROUP CLASS 1 HCP - (1350 METRES)

DOONICAN (IRE) – Slow to begin.

REDOLLIX – Apprentice L Bingley was reprimanded under the provisions of AR131(a) careless riding for allowing her mount to shift in passing the 1200 metres, resulting in rider D Pires having to restrain out of his position.

CORNELIAN BAY – Stewards spoke to Rider D Pires regarding the geldings below market expectations of the gelding. Rider D Pires stated that the gelding failed to respond to his riding until near the 600 metres. He also stated that the gelding felt shin sore. Steadied off the heels approaching the 1200 metres when REDOLLIX shifted in. Hung in over the concluding stages and was unable to ride his mount out fully to the line. A post-race veterinary examination failed to reveal any obvious abnormalities.

GAUDI GIRL – Shifted wider on the track at about the 200 metres.

RACE 5 – KEVIN SHARKIE MDN/CL1 - (1880 METRES)

EXPENSIVE MISTAKE – Stewards spoke with rider D Pires in relation to the below market expectations of the gelding. Rider D Pires stated that it was the geldings first start at the track and over the distance. A post-race veterinary examination failed to reveal any obvious abnormalities.

FIFE AND DRUM – Raced wide throughout.

POP A HONDA – Fractious in the barriers prior to the start. Rider reported that the gelding was on one rein, and he was unable to control the gelding when entering the home straight. Trainer C Thompson was advised a warning had been placed on the gelding for hanging. Trainer C Thompson advised the gelding would now be spelled.

REAL MONSTER – Over raced in the middle stages of the race.

ROCKYMOUNTAINHIGH – Stewards spoke to Trainer J Keys regarding the mares disappointing below market expectations. Mr Keys stated that he disappointed with a similar performance at the mares' previous start and it is his intentions to have the mare scoped. Stewards advised if there was nothing amiss with the mare that it would be required to complete a satisfactory trial prior to racing again. A post-race veterinary examination failed to reveal any obvious abnormalities. Stewards to follow up with the Trainer.

TOUGH COOKIE – Raced wide throughout.

UNNERVING – Stewards spoke with trainer P Dargan in relation to the poor performance of the gelding. Stewards noted that rider D Tootell from the wide barrier draw was unable to find a position to slot in and race closer to the rail. Trainer P Dargan advised that the gelding would now go for a short spell. Stewards to follow up.

LISKAMM – Held up for a clear run near the 250 metres.

PAGE – Held up passing the 400 until the 300 metres, checked when POP A HONDA hung in severely at about the 250 metres.

RACE 6 – BIRDCAGE TAVERN BM69 HCP - (1880 METRES)

Stewards queried riders T Johnstone (DARGO) and E Byrne Burke (Irish Shotgun) in relation to tactics adopted which resulted in both horses leading the main body of the field after working forward due to the slow pace. The inquiry was adjourned so Stewards could establish the sectional times of the relevant section of the race.

Delay to correct weight as Trainer R Hamer wished to view the official judge's photo, after viewing correct weight was declared on the judges numbers.

PERUN (NZ) – Under-went a post-race veterinary examination which failed to reveal any obvious abnormality. Stewards to follow up with trainer.

JOHN'S LAD – Stewards spoke to Apprentice C Baker in relation to clipping heels of TEE JAY FRANKIE at about the 400 metres, which had compounded quickly at that point. Apprentice C Baker was advised to exercise more care in the future.

DARGO – Raced wide throughout.

IRISH SHOTGUN – Worked forward Tired from the 500 metres

TEE JAY FRANKIE – Beaten in excess of 36 lengths. Trainer S Gandy advised that the gelding would now be retired. Mr Gandy was advised if the gelding was to be re-instated at any time it must complete a satisfactory trial prior to racing again.

SUBMIT ANOTHER – Stewards granted permission for rider B Neto to ride 1kg over the allotted minimum weight.

RACE 7 – LEAPING GOAT COFFEE CO BM76 HCP - (1650 METRES)

SIR SIMON – Shifted in under pressure near the 200 metres.

POLITICAL – Raced ungenerously in the early stage

WELDBOROUGH – Over-raced in the middle stages

RING OF HONOUR – Over-raced in the middle stages

GEE GEES MAGIC MAN – Stewards granted permission for rider B Neto to ride 1kg over the allotted minimum weight, raced fiercely and travelled three wide throughout.

RACE 8 – TASMANIAN HORSE TRANSPORT BM68 HCP - (1150 METRES)

ASPIRATE – Had to be restrained approaching the 800 metres after clipping the heels of WEEKEND WHISKEY, which had shifted out.

BANDINELLI – got its head up and raced fiercely in the early stages, over raced and raced fiercely approaching the 600 metres and shifted wider to avoid the heels of GEE GEE LANETT which had shifted in when not fully clear.

GEE GEE TRUE STORY – Raced wide throughout.

GEE GEE LANETT – Rider B Neto was reprimanded under the provisions of AR131(a) careless riding for allowing his amount to shift in when insufficiently clear of BANDINELLI and SUMMER FIRE at about the 850 metres.

WEEKEND WHISKY – Over-raced in the middle stages, shifted out approaching the 800 metres off the heels of BANDINELLI which was racing fiercely.

EMILY – Raced wide throughout.

SIRENE STRYKER – Rider D Ganderton was advised to exercise care when shifting out passing the 800 metres and bumping with WEEKEND WHISKY.

TROJAN STORM – Held up from the 250 metres to the 100 metres.

RACE 9 – GREAT NORTHERN BM60 HCP - (1350 METRES)

Stewards delayed correct weight at the request of the Starter to view the official patrol films in relation to the barrier gates opening. After viewing stewards were satisfied that all gates opened simultaneously and no runner was disadvantaged, correct weight was declared on the judges' numbers.

THE EXECUTIVE – Bumped with GEE GEE RHYTHM passing the 350 metres resulting in the gelding being carried wide on the turn.

IVORYMAN (NZ) – Slow to begin.

NEEDS TOASTING – Over raced in the early and middle stages of the race. Stewards spoke to Apprentice E Byrne Burke regarding her riding in the home straight. When allowing her mount to shift out. Rider E Byrne Burke stated that she accidentally dropped the right rein passing the 200 metres. Apprentice E Byrne Burke was advised to exercise more care

ALPINE BLAST – Laid in approaching the 200 metres. Bumped with NEEDS TOASTING on severely occasions and was carried wider on over the concluding stages.

THE BEEKEEPER – Raced fiercely and three wide throughout.

GEE GEE RHYTHM – Shifted out passing the 350 metres bumping THE EXECUTIVE which carried IVORYMAN wider.

STELLADONI – Slow to begin

RACE 10 THAI IMPERIAL BM60 HCP – (1009 METRES)

ARTUSO – Slow to begin.

GEEGELUCKYSTAR – Fractious in the barriers

VETLANDA – Declared a late scratching at 4:46PM on veterinary advice after becoming fractious in the barriers, rearing and hitting its head. Trainer B Campbell was advised the mare must complete a satisfactory trial prior to racing again. All monies invested on the mare were ordered to be refunded in full, with the following deductions.

1 st GEE GEES SO TRUE	27 cents a win, 19 cents a place
2 nd SPARKLING ONE	25 cents a place
3 rd ARTUSO	25 cents a place

WORDS OF PRIDE – Held up rounding the home turn behind GINNY ANN.

GEE GEES SO TRUE – Apprentice C Wells was advised to exercise more care when shifting ground approaching the 600 metres. Momentarily became unbalanced at about the 200 metres, shifted out over the concluding stages.

NEUTRALIZE – Stood flat footed and was slow to begin, raced wide throughout.

ENTRAPPED – Fractious in the barriers, jumped awkwardly, raced wide throughout.

ELLA EXCEEDS – Over-raced in the middle stages, inconvenienced when GEE GEE SO TRUE shifted in
