Acting under the provisions of GAR127(a), Just Casper has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial. Legal Tender underwent a post-race veterinary examination and was detected to have superficial laceration to its left wrist. However, no stand down period was applied. A post-race swab sample was taken from Just Casper.
