Fernando Rose completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 12th of September 2022 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR125. Weighing 24.3 kilograms and beginning from box 3, Fernando Rose completed the 278-metre trial distance in a time of 16.55. As Fernando Rose eased approaching the first turn, the greyhound failed to trial to the satisfaction of stewards. As a result, Fernando Rose has not been cleared to race.
