Little Blue Man has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr P Young in relation to the racing manners of Little Blue Man. in particular approaching the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr P Young. Stewards were of the opinion that Little Blue Man had visibly eased free of interference on the first and in doing so had failed to pursue the lure, with due commitment throughout the event, by reason of injury pursuant to GAR 125. Little Blue Man has been stood down from racing for a period of 7 days and until the completion of a satisfactory trial.
