Meet In has been stood down from racing for a period of 28 days and until the completion of a satisfactory trial. Dewana Cruiser underwent a post race veterinary examination and was found to have a possible fracture of the right hindleg. Dewana Cruiser has been stood down from racing for a period of 120 days. Dewana Speed underwent a post race veterinary examination and no apparent injury could be detected.
