## **GENERAL**

Fernando Rose completed a steward's satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 12<sup>th</sup> of September 2022 for failing to pursue the lure by reason of injury and, also for approval to wear blinkers in future events, pursuant to GAR125(1)(a) and GAR91(1) respectively. Weighing 24.0 kilograms and beginning from box 3, Fernando Rose completed the 278-metre trial distance in a time of 16.31 placing first. Fernando Rose has been cleared to race all tracks and has also gained approval to wear blinkers in future events.

Call Me Otto completed a steward's satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 26<sup>th</sup> of September 2022 for failing to pursue the lure and, also for approval to wear blinkers in future events, pursuant to GAR124 and GAR91(1) respectively. Weighing 37.7 kilograms and beginning from box 5, Call Me Otto completed the 278-metre trial distance in a time of 16.56 placing third. Call Me Otto has been cleared to race all tracks and has also gained approval to wear blinkers in future events.
