Acting on their own observations, viewing the official replays and taking evidence from Mr Clark, Stewards were of the opinion that Roxy Danger had turned its head outwards and had made head and muzzle contact with Summertime Sad and by doing so had marred the running of that greyhound pursuant to GAR123(1). Acting under the provisions of GAR127(1)(b), Roxy Danger has been stood down from racing for a period of 28 days at all tracks and until the completion of a satisfactory trial.

After races 3 and 5, stewards spoke to lure driver Mr S Williams in regard to the position of the lure from the lead greyhound throughout these events. Mr Williams was reminded that the lure should be no less than 5 metres and no greater than 8 metres ahead of the lead greyhound.

Speedy Noodle completed a steward's satisfactory trial as it hasn't started in an event for in excess of six months pursuant to GAR135. Weighing 27.1 kilograms and beginning from box 3, Speedy Noodle completed the 278-metre trial distance in a time of 30.07. Speedy Noodle has been cleared to race all tracks

Oriental Elsa completed a steward's trial over the 278-metre trial distance after having been stood down pursuant to GAR131(1)(d) for an unsatisfactory performance on the 4<sup>th</sup> November 2022 at the Hobart Greyhound Racing Club meeting. Weighing 28.6 kilograms and beginning from box 3. Oriental Elsa completed the 278-metre trial distance in a time of 16.49. Oriental Elsa has been cleared to race at all tracks.
