Big Red Ruby underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to trainer representative Mr P Gregory relation to Big Red Ruby's racing manners, in particular rounding the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Gregory, Stewards were of the opinion that Big Red Ruby had turned its head outwards and had made head and muzzle contact with Defender Danger and by doing so had marred the running of that greyhound pursuant to GAR123(1). Acting under the provisions of GAR127(1)(b), Big Red Ruby has been stood down from racing for a period of 28 days at all tracks and until the completion of a satisfactory trial.
