Comments / Explanations:

Stewards accepted the explanation for B Neto being indisposed for this meeting.

Trainer R Hamer was fined \$50 under the provisions of LR13.3 for a late rider declaration for ASPIRATE in Race 6.

Stewards spoke to rider T Johnstone in relation to her being unable to ride at her minimum riding weight. Stewards reminded rider T Johnston under the provisions of AR143(14)(a) in claiming her full allowance she must seek permission from stewards in future and that trainers and owners should be made aware if she is unable to make a full claim.

RACE 1 – BECOME A MEMBER AND REAP THE REWARDS MAIDEN (1100M)

EYES FOR ASH – Over raced early, restrained at approximately the 50 metres when DING DING rolled in marginally and EYES FOR ASH rolled out.

WHEELNOT – Jumped awkwardly and was slow to begin, raced greenly throughout, laid out making the turn approaching the 600m.

MATEUS – Slow to begin, rider S Carr advised that the gelding raced greenly throughout. A post race veterinary examination failed to reveal any obvious abnormalities.

BLOW UP – Re-saddled behind barriers prior to the start. Rider D Ganderton reported to stewards on returning to scale that there was something amiss with the mare and that in his opinion the mare had jarred up in the run and had failed to run

on. A Post race veterinary examination failed to reveal any obvious abnormalities. Stewards to follow up with trainer.

EGAO – Approaching the 500 metres shifted in WHEELKNOT had to be restrained off heels

GEEGEEPOWERPLUS – Crowed on jumping between DING DING and EYES FOR ASH which both shifted ground.

MISS SLEUTH – Trainer P Luttrell when questioned on the improved performance stated that he always believed the horse to have ability. He said that the addition of blinkers and back in distance had helped. He also stated that the mare had over-raced in previous starts but had settled in its run tonight.

DING DING – Shifted in approximately 50m Rider D Pires reported that his mount failed to let down.

GEEGEE MADEN OVER – Laid in the home straight

RACE 2 – LADBROKES SAME RACE MULTI MAIDEN (1600M)

ALPINE ASSAULT – Bumped on jumping with AUSSIE BLACK

AMERICAN JEWEL – Slow to begin, momentarily held up home turn, disappointed for a clear run approaching the 150 metres when FAIRY FLING shifted in to race tightly to his outside then AMERICAN JEWEL elected to shift in and take a run to the inside of GIRIDO

AUSSIE BLACK – Bumped on jumping with ALPINE ASSAULT

RUSTIC CHARM – Over raced middle stages, hung in going past the 600m

GEEGEE'S BIG BIRD – Bumped with SMASHING HIT at the start, over raced early and middle stages, hung in in the home straight.

A WEE NIP – over raced early stages

SMASHING HIT – Jumped awkwardly, threw its head in the air, shifted out and bumped with GEEGEE'S BIG BIRD, over raced middle stages.

RACE 3 – LADBROKES MARKET CONTROL CLASS 1 HCP (1600M)

POET WARRIOR – Raced three wide without cover to the 800 metres, over raced early and middle stages

SPEED ROCK – Rider M Ulucinar was advised to take more care on allowing his horse to shift ground after the winning post

OLE OLA – Fractious in the barriers, immediately after the start had been affected with the gates opening, unbalanced the rider when the horse contacted the side of the barriers resulting in the barrier attendant taking hold of the near side rein with the mare

losing considerable ground on jumping. Under the provisions of AR204(1)(d) encumbered by any other outside influence after gaining a fair start cannot be declared a non-runner due to running second place. Over raced early and middle stages, momentarily laid in at about the 200 metres.

OLYMPIC HONOUR – Rider D Pires was reminded of his obligations in relation to his whip action and ensuring that his arm doesn't go above shoulder height.

BAHEERA – Stewards granted permission for Rider T Johnstone to not claim her full allowance. Rider T Johnstone was advised to exercise care when allowing her mount to shift inwards after the winning post.

RACE 4 – MEMBERS ARE OUR BACKBONE 0-62 (1400M)

GEE GEE CAN WIN – Stewards advised rider B McCoull of his obligations to exercise more care when shifting out wider to make a run about the 200 metres in the home straight when forcing THE BEEKEEPER wider.

HAS THE LOOK – Raced three wide throughout

THE BEEKEEPER – Bumped at the start by MAGIC TYPHOON over raced at 1100 metres and shifted out onto HAS THE LOOK.

OFF PEAK(NZ) – Rider D Parish was questioned on the mares below market performance. Rider D Parish stated that the mare shorten strides at the 600 metres and in her opinion, she believed the track was too firm.

MAGIC TYPHOON – Stewards granted permission for rider S Carr to ride 1kg over the allotted weight of 54kg, shifted in on jumping bumping THE BEEKEEPER Rider S Carr reported it was inclined to over race throughout steadied off the heels of THE BEEKEEPER around the 1200 metres as a result of over racing.

RACE 5 – MEMBERS CASH BACK BOOK 0-62 (1100M)

IMAGINE HOWE – Commenced to over race at approximately 700 metres when being restrained off heels of UNDER HIS EYE and then shifted out onto MARIPOSA, Trainer A Trinder believed that after over racing and pulling hard throughout had not assisted the gelding in tonight's run.

LADY JOKER – Bumped with GEE GEE RHYTHM at the start.

SHARE THE GOLD – Bounded on jumping, slow to begin.

UNDER HIS EYE – Over raced making the 800 metre turn.

WHEELING – Over raced early and middle stages.

GEE GEE RHYTHM – Bumped with LADY JOKER at the start, Inconvenienced by UNDER HIS EYE which had been forced wider at about the 700 metres.

TIDAL – Rider S Carr was questioned on her tactics adopted in the early stages of the race when electing to slow the pace of the race. Rider S Carr was reminded of her obligations under the provisions of AR131(d) excessively slow, reduce or check the speed of the riders horse and in doing so cause direct or indirect interference to any other horse in the race.

MARIPOSA – Shifted out at approximately 700 metres inconveniencing GEE GEE RHYTHM

RACE 6 – McB DEVELOPMENTS 3YO CUP 23RD NOVEMBER BM68 HCP (1400M)

JEREMIAH – Three wide without cover throughout, shifted in about the 1200 metre turn when not fully clear of MAARKLE, rider E Byrne Burke was reprimanded under the provisions of AR131(a) careless riding for shifting in when not fully clear. A post-race veterinary examination revealed no abnormalities.

ASPIRATE – Rider I Toker was reprimanded under the provision of AR131(b) for failing to ride his mount out fully to the line. Rider I Toker was also reprimanded under the provisions of AR128(2) for leaving the course without permission.

CLIFTON DANSEUR – Stewards questioned rider T Baker on the disappointing performance of his mount. He stated that the horse failed to respond when placed under pressure. Post-race veterinary examination failed to reveal any obvious abnormalities.

MAARKLE – Steadied off heels of JEREMIAH near the 1200 metres, commenced to over-race at about the 900 metres when steadying off the heels of JEREMIAH.

RACE 7 – BEAT THE SHARK BM68 HCP (1200M)

EASY ROAD (NZ) – Fractious in the barriers before the start had to be withdrawn and underwent a pre-race veterinary examination and was passed fit to race. Raced three wide throughout.

JOHNNY CHUTZPAH – over raced early, shifted out at approximately the 400m when not sufficiently clear of PEACE BE UPON HIM. Rider B Muhcu was advised to exercise more care when attempting to improve.

RACE 8 – JACKSON SECURITY TASMANIAN NEWMARKET 30TH NOVEMBER CLASS 1 HCP (1200M)

Delay to correct weight when connections of both horses requested to view the official photo finish of the dead heat. After viewing correct weight was declared on the judges numbers.

ANOTHER PREDICTION – Made heavy contact to the inside of the barriers and reared on jumping, slow to begin. Three wide throughout. Trainer P Hill was advised that the warning is continued for rearing on jumping.

BE KINDER – Contacted the side of the barriers on jumping, over raced early and middles stages, steadied off the heels of BYNANCE approaching the 700 metres.

R8 - NEXTRA KINGS MEADOWS NEWSAGENCY BM60 HCP(1200m)

Rider I Toker (GEE GEE ALS PRINCE) pleaded guilty to a charge under the provisions of AR132(7)(a)(i) for using his whip on consecutive strides on two occasions prior to the 100 metres. Rider I Toker was fined the sum of \$300. In assessing penalty

stewards took into account his guilty plea and his record under this rule. Rider I Toker was advised of his right of appeal.
