RACE 1 – PST POWER SOLUTIONS 2YO MAIDEN (900 METRES)

AKYRIA – Declared a late scratching at 1.13pm on veterinary advice after becoming fractious in the barrier. The filly will be stood down from racing until the completion of a satisfactory trial. Stewards ordered that the following deductions apply to all winning bets prior to 1.13pm.

1ST – 5 LIBERTY RAE
2ND - 4 HILARITY

16 cents Win – 19 cents Place
12 cents Place

BELLE BLONDE – Shifted out on jumping bumping with LIBERTY RAE. Over raced approaching the 600 metres and hung in for the entire home straight.

GRETAL – Hung in home straight.

HILARITY – Slow to begin and slow to muster early speed.

LIBERTY RAE – Bumped at the start.

RIDE THE MOON – Stewards granted permission for rider M Ulucinar to ride 1kg over the allotted weight. Declared a late scratching on veterinary advice after becoming fractious in the barriers and rearing and becoming momentarily cast. The filly will be stood down from racing until the completion of a satisfactory trial. Stewards ordered that the following deductions apply to all winning bets prior to 1.12pm.

1ST – 5 LIBERTY RAE
2ND - 4 HILARITY

RACE 2 – DERWENT PARK PLUMBING MAIDEN (1400 METRES)

STEEL MIST – Over raced in the early stages and shifted out near the 1100 metres and carried HATHAWAY wider.

THE CONTAMINATOR – A post-race veterinary examination revealed a poor heart rate recovery.

VIVRE IS THE WORD – A post-race veterinary examination revealed a poor heart rate recovery.

BELPINE MISS – Became fractious and reared in the barriers and was declared a late scratching on veterinary advice at 1.47pm. The mare will be stood down from racing until the completion of a satisfactory trial. Stewards ordered that all bets on BELPINE MISS are to be refunded in full with the following deductions:

1ST – 6 ROYAL AND TOUGH
2ND – 9 FRYER HILL
3RD – 12 SIRENE'S LILLY

ELLE OF A BREEZE – A post-race veterinary examination revealed a poor heart rate recovery.

MILLA'S READY – Checked on jumping when MISS PECULIAR was carried in by HATHAWAY.

HATHAWAY – Shifted in on jumping crowding MISS PECULIAR. Carried wider near the 1100 metres when STEEL MIST shifted. A post-race veterinary examination revealed a poor heart rate recovery.

MISS PECULIAR – Crowded on jumping.

RACE 3 – MCKAY TIMBER MDN / CL 1 (2100 METRES)

CHI MAZEL – Over raced in the early and middle stages.

EAGLE STREET – Over raced early, shifted in under pressure from the 150 metres.

SOUTHERN WIND – Race three wide throughout and carried wider near the 1100 metres. Rider reported that his saddle slipped in the middle stages placing him at a disadvantage throughout.

CORONATION APACHE – Worked forward in the middle stages.

PREWINGO – Rider M Ulucinar advised stewards that the gelding was reluctant to take the tight run that presented near the 50 metres.

RACE 4 – GARY LOCKLEY PAINTING BM76 HCP (2200 METRES)

ONE LOTTO – Bounded on jumping. Rider D Pires reported he raced further back than intended as a result. He then elected to progress forward from the 1600 metres to the 1400 metres. D Pires was advised to exercise care when allowing his mounts to shift ground in the home straight.

UP WIND – Bounded on jumping and slow to begin.

STEEL SKIES – Carried wider in the home straight when placed awkwardly on the heels of ONE LOTTO.

PAGE – Trainer reported that he believes that the mare may not be suited to the track at Hobart.

RACE 5 – PST POWER SOLUTIONS BM60 HCP (1200 METRES)

DAY PERFORMER (NZ) – Raced three wide.

GEE GEE ALS PRINCE – Steadied off heels near the 900 metres and shifted out onto IRIS WEST.

IRIS WEST – Caught wide throughout and over raced in the early stages when carried wider by GEE GEE ALS PRINCE.

GEE GEE GOLDENLASS – A post-race veterinary examination revealed minor abrasions to the near hind heel and canon.

SUNSET GUN – A post-race veterinary examination revealed no obvious abnormalities.

CAPTAIN DAVE – Raced wide in the early stages.

RACE 6 – GLENORCHY ROTARY RACE DAY CL1 HCP (1100 METRES)

I'M KRUPT – Laid out in the home straight.

DOMINATOR'S GIRL – Raced three wide throughout. Laid in entering the home straight.

HOT WIRED – Slow to muster early speed. When questioned on the improved performance D Pires stated the horse was returning from an extended spell and may have appreciated the track being rated soft five.

UNIQUE GLOW – Slow to begin.

SMOKIN' HARD – Raced wide throughout.

RACE 7 – PST POWER SOLUTIONS GOODWOOD HCP (1100 METRES)

GEE GEE SECONDOVER – Shifted in and brushed with OURCONI near the 850 metres. Commenced to over race and shifted in bumping heavily with OURCONI shortly afterwards.

FIRST ACCUSED – Raced wide throughout.

BLAZE FORTH – Raced wide throughout

JULIUS – Over raced in the early stages. Stewards questioned rider M Ulucinar on the below market performance of the gelding. Rider M Ulucinar stated that the gelding travelled well early but when placed under pressure it failed to respond to his riding. He also stated that in his opinion the gelding didn't handle the track conditions at today's meeting. A post-race veterinary examination revealed a slow heart rate recovery

JA JA CHABOOGIE – Raced three wide without cover throughout.

OURCONI – Stewards granted permission for rider T doyle to ride 1kg over the allocated weight. Brushed near the 850 metres when GEE GEES SECONDOVER shifted in, then bumped heavily shortly after and lost its position due to GEE GEES SECONDOVER commencing to over race.

RACE 8 – ANDREW WALTER COSTRUCTION BM60 HCP (1600 METRES)

ARGYLE BEACH – Raced wide in the early and middle stages.

NICCO THE GREEK – Rider D Pires reported that in his opinion the gelding failed to run out the 1600 metres. A post-race veterinary examination revealed a poor heart rate recovery.

MOSHAMA – Slow to begin and then commenced to over race near the 1400 metres.

NORTHERN SPIRIT – Raced wide throughout.
