Comments / Explanations:

Trainer S BRUNTON was fined \$150 under the provisions of LR13.3 for a late rider declaration for horses in races 1 – SAVS FINALE, Race 3 – WOUNDED MISS and race 9 – FINXY.

RACE 1 – LONGFORD CUP NEW YEAR'S DAY BM76 HCP (1400M)

SH'BOURNE REBEL – Rider T Johnstone was reminded of the provisions of AR 132(7)(a)(ii) when her whip use came under notice. Upon inquiry and viewing the films it was established two of her attempts to use the whip did not make contact with the horse. As a result she had not a breached the rule.

AZARA – Over-raced early stages.

RACE 2 – LADBROKES MONEY BACK ODDS MAIDEN (1400M)

BAVARIAN FLYER – Shifted out under pressure approaching the winning post.

DAKOTA PARK – Laid in approaching the winning post.

GALAN – Laid out in the home straight.

MIGHTYMAXI – Fractious in the barriers, raced three wide throughout., laid in from the 600 metres until the winning post. A post-race veterinary examination revealed the gelding had suffered Atrial Fibrillation. Stewards have directed that MIGHTYMAXI must complete a 1000 metre gallop and have a veterinary clearance with the result of an ECG before trialling or racing again.

WADDY WADDY – Raced three wide in the early stages. Laid out in the home straight.

FIGHTING GRACE – A post race veterinary examination failed to reveal any abnormalities.

GOES LIKE THE WIND – Placed in restricted room momentarily at about the 50 metres between DAKOTA PARK and BAVARIAN FLYER which had both shifted ground marginally.

RACE 3 – McB DEVELOPMENTS 3YO CUP 23RD NOVEMBER MAIDEN (1200M)

BARATO – Began awkwardly, raced wide throughout.

ADA WAY – Difficult to load, over-raced early and middle stages, a warning has been placed on the gelding's loading manners.

ARAPTOR – Bounded on jumping and was slow to begin.

BERSERKER – Bumped with SISTINE at the start.

ZULU ESPRIT – Shifted out at about the 100 metres when not fully clear of ZULU ROSE which had to shift in to maintain clear running. Rider T Johnstone was reminded of her obligations when shifting ground.

GONE GLOBAL – Declared a late scratching at 6.35pm by order of stewards when the mare was unable to be loaded. The mare will be stood down from racing until the completion of a satisfactory trial. Stewards ordered all bets on the mare be refunded and that the following deductions apply to all bets prior to 6.35pm.

1ST – SISTINE	6 cents Win – 6 cents place
2ND – ADA WAY	6 cents place
3RD – FROLAND	10 cents place

WOUNDED MISS – Bumped with SISTINE at the start.

SISTINE – Bumped with WOUNDED MISS shortly after the start.

ZULU ROSE – At about the 100 metres shifted out under pressure.

FROLAND – Shifted in on jumping hampering BARATO, raced three wide throughout.

MYOCARDIUM – Began awkwardly.

RACE 4 – LADBROKES IT! BM68 HCP (1100M)

REBEL FACTOR – Shifted wider near the 600 metres carrying DEBRIEF wider.

ASSARANCA – Slow to begin and slow to muster early speed, over raced middle stages. Shifter wider passing the 600 metres when Debrief was carried out.

DEBRIEF – Began awkwardly and was slow to begin, carried wider by REBEL FACTOR near the 600 metres.

HANNAH’S SONG – Rider S Carr was reminded of her obligations to ensure she rides her mounts out fully to the line.

MAJESTIC DIAMOND – Shifted out under pressure near the 100 metres.

RACE 5 – LADBROKES BLENDED MULTIS CLASS 1 (1200M)

LION’S TOOTH – Slow to begin.

NEEDS TO BELONG – Slow to begin, restrained off heels of WANE’S QUEST shortly after the start. Shifted in near the 300 metres off the heels of PUNK PRINCESS.

WANE’S QUEST – Bumped with ROCK’EM BABY at the start.

GEE GEE SNOWFLAKE – Over-raced early stages, laid out the entire home straight. Rider T Johnstone stated that when placing the mare under pressure from the 400 metres that it failed to respond to her riding.

ROCK’EM BABY – Bumped with WANE’S QUEST at the start.

HEAVEN’S MIRACLE – Rider C Baker reported she accidentally dropped her whip near the 50 metres.

PUNK PRINCESS – Rider G Catania shifted out near the 300 metres when not fully clear of NEEDS TO BELONG which had to shift in to maintain clear running. Stewards reminded rider G Catania of her obligations to ensure she is fully clear when shifting ground.

RACE 6 – CRESSY CHAFF CUTTERS CLASS 3 HCP (1200M)

BREW HORSE – Bumped with JUST A TRIBUTE at the start.

JUST A TRIBUTE – Bumped with BREW HORSE at the start.

OUTBOUND – Jumped awkwardly at the start and threw its head in the air shortly after. Over raced early and middle stages. Restrained off heels near the 900 metres when QUEENBOROUGH FLYER crossed to the rails when not fully clear.

GEEGEE LUCKY JESS – Raced wide throughout.

QUEENBOROUGH FLYER – Rider S Carr was severely reprimanded under the provisions of AR131(a) careless riding for allowing her mount to shift in near the 900 metres when not fully clear of OUTBOUND which had commenced to over race and had to be restrained.

RACE 7 – LADBROKES MARKET CONTROL BM62 HCP (2100M)

ASHMANIA – Re-saddled behind barriers.

MOSCOW MULE – Jumped awkwardly at the start and was slow to begin. Held up for a clear run on the home turn behind JOHN'S LAD.

JOHN'S LAD – Held up on the home turn behind THE DECIDER.

THE DECIDER – Raced three wide throughout. Bumped with OLYMPIC HONOUR and became unbalanced near the 300 metres.

HAMPTON BAY – Bounded on jumping and was slow to begin, raced wide throughout.

OLYMPIC HONOUR – Slow to begin. Shifted in at about the 300 metres bumping with THE DECIDER at the same time the DECIDER had shifted out. Laid in over the concluding stages, rider D Pires had to stop and straighten his mount.

RACE 8 – BOOK IN NOW FOR YOUR XMAS DINNER BM60 HCP (1400M)

SECRETLY AWESOME – Held up momentarily entering the home straight.

BERRUTI – Jumped awkwardly and was slow to begin. Hampered shortly after the start when SPIRITED TOFF shifted out. Obligated to shift wider to obtain clear running when following INCRIMINATE which commenced to tire on the home turn.

SPIRITED TOFF – Jumped awkwardly, shifted out shortly after hampering BERRUTI.

HAS THE LOOK – Raced three wide until the 800 metres. Rider C Baker reported the mare laid in, in the home straight.

RACE 9 – JACKSONS SECURITY TASMANIAN NEWMARKET 30TH NOVEMBER CLASS 1 HCP (1400M)

KAYTEE VALIENTE – Shifted out under pressure in the home straight.

FINXY – Raced three wide throughout.

KLATTEN – Rider G Catania was queried on the performance of the mare. Rider G Catania stated that in her opinion the mare was one paced and would be better suited over more distance.

POWERFUL PEBBLES – Slow to begin.
