Into The Fire underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke with trainer Mrs S Martin in relation to the race manners of Into The Fire. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Into The Fire had eased when approaching the first turn and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR124(1). Into The Fire has been stood down from racing for a period of 28 days and until the completion of a satisfactory trial.

GENERAL

Buckle Up Zabiba completed a weight trial pursuant to GAR120(1). Weighing 29.5 kilograms and beginning from box 3, Buckle Up Zabiba completed the 278-metre trial distance in a time of 16.58. Buckle Up Zabiba has been cleared to race at all tracks

Just Casper completed a steward's satisfactory trial over the 278-metre trial distance after having been stood down at the Hobart Greyhound Racing Club on 15th September 2022, for failing to pursue the lure, pursuant to GAR124(1). Weighing 31.4 kilograms and beginning from box 5. Just Casper completed the 278-metre trial distance in a time of 16.40. Just Casper has been cleared to race at all tracks except Hobart and up to 278m.
