***Comments / Explanations:***

*Stewards accepted the explanation for late rider declarations for trainers S Brunton and T Romeo.*

**RACE 1 – HYPE TV 2YO MAIDEN (1000 METRES)**

**GRETAL** – Rider M Ulucinar reported that his saddle had shifted at around the 500 metres placing him at a disadvantage for the remainder of the race.

**HILARITY** – Bumped with NEEDS SUGAR shortly after the start

**KABOOM KABOOM** – Fractious in the barriers prior to the start. A warning has been placed on the filly's barrier manners.

**NEEDS SUGAR** – Fractious in the barriers prior to the start. Shortly after the start bumped with HILARITY, continued to race greenly throughout the event.

**RACE 2 – TONY CARRICK VASE MAIDEN (1200 METRES)**

Prior to correct weight rider D PIRES wished to view the official photo finish and the official race films from the 600 metres. After viewing the photo and the race films correct weight was given on the judges' numbers.

**EYES FOR ASH** – Slow to begin and over raced in the early and middle stages.

**ROHZHAE** – Bumped with RUBBLEONTHEDOUBLE shortly after the start.

**STEEL MIST** – Slow to muster early speed.

**SUPERCRAFT** – Declared a late scratching at 10:28 am on veterinary advice due to an elevated temperature. Trainer S Brunton was advised that a veterinary clearance will be required prior to the horse racing again.

**BOBBY BOBBY** – Slow to begin, post-race veterinary examination revealed no apparent abnormalities.

**MOVEFORLEX** – Jumped awkwardly and contacted side of the barrier, raced three wide throughout, shifted in under hard riding from to the 200 metres.

**RUBBLEONTHEDOUBLE** – Began awkwardly shifting out contacting ROHZHAE.

**ZOU ZOU ZOU** – Slow to begin.

**MYCARDIUM** – Raced wide throughout.

### **RACE 3 – RAINE & HORNE EASTERN SHORE MAIDEN (1400 METRES)**

**FREDDY'SAJETSTAR** – Laid in over the concluding stages.

**LITTLE LIONEL** – Stewards granted permission under the provisions of AR 106(2) for this gelding to wear blinkers. Trainer S Brunton was fined the sum of \$100. Jumped awkwardly and brushed with ELUSIVE PRINCESS.

**UPPERCUTS** – Raced wide throughout

**BANCA GLEE** – Raced wide throughout, held up at the top of the straight and shifted ground inwards to improve its position.

**MILLA'S READY** – Raced wide in the early and middle stages.

**SMASHING HIT** – Slow into stride.

**ELUSIVE PRINCESS** – Laid in over the concluding stages.

### **RACE 4 – KELLY CIVIL CONTRACTING BM60 HCP (1400 METRES)**

**RAVAGE** – Slow to muster early speed.

**WE DESERVE THIS** – Stewards questioned trainer S Brunton in relation to the improved performance of the gelding. Mr Brunton stated that they had attempted to have the horse forward in previous races but weren't able to. In his opinion the barrier draw and the positioning forward early has assisted the gelding on its run today.

**CAPTAIN DAVE** – Raced wide throughout.

**FINXY** – Raced four wide throughout. Trainer S Brunton advised stewards that he will be re-assessing the geldings future racing plans.

**THE BEEKEEPER** – Brushed with HERMANS BELLS entering the home straight.

Stewards questioned rider I TOKER to the below market performance of the horse. Rider I TOKER stated in his opinion the horse failed to back up from its previous start, also stating that the horse pulled hard throughout and failed to respond when placed under pressure in the home straight. A post-race veterinary examination failed to reveal any apparent abnormalities.

**SMOKIN' HARD** – Rider S CARR pleaded guilty to a charge under AR 132(7)(a)(ii) in that she used the whip on eleven occasions prior to the 100 metres, six more than permitted. In assessing penalty Stewards considered her guilty plea, recent good record, and that the breach was in the high range. Stewards fined Ms. Carr the sum of \$300.

**HERMAN'S BELLS** – Raced four wide until the 600 metres. Brushed with the BEEKEEPER entering the home straight.

### **RACE 5 – RAINE & HORNE KINGSTON BM76 HCP (2400 METRES)**

**ONE LOTTO** – Restrained off the heels of STEEL SKIES at the 1200 metres.

**UP WIND** – Slow to begin, carried wider on the home turn when EAGLE STREET shifted out to improve its position. Underwent a post-race veterinary examination that revealed no apparent abnormalities.

**STEEL SKIES** – Stewards granted permission for rider C Atkinson to ride 1kg over the allotted weight. Connections advised a change of tactics and that they would attempt to go forward circumstances permitting. Re-saddled behind the barriers.

**EAGLE STREET** – Shifted in and bumped with JOHN'S LAD upon jumping. When attempting to restrain shortly after the start the gelding had a tendency to over race. Rider D Pires was questioned on the apparent below market performance of this gelding. Rider D Pires stated that tempo of the race didn't suit and failed to respond when tested at the 1500 metres and again at the 600 metres.

**JOHN'S LAD** – Rider Erica Byrne Burke was granted permission to claim 1kg of her allowance.

**DIXIE'S BOY** – When questioned on the geldings apparent improved performance rider A Darmanin stated that he believed the pace suited today and trainer T Keys added that the horses training routine had been changed along with being put over the jumps since its last start.

### **RACE 6 – RAINE & HORNE COMMERCIAL HOBART BM68 HCP (1200 METRES)**

Connections of JOHNNY CHUTZPAH asked to review the official patrols films of an incident approaching the 100 meters. After viewing the patrol films, correct weight was declared on the judge's numbers.

**DUNBRODY POWER** – Rider E Byrne Burke was reprimanded under AR 131(a) careless riding in that she allowed her mount to roll out at the 100 metres when not sufficiently clear of JOHNNY CHUTZPAH causing rider B Muhcu to check his mount.

**JOHNNY CHUTZPAH** – Slow away and over raced in the early stages. Rider B Muhcu was reprimanded under AR 131(a) careless riding in that he allowed his mount to shift out at the 180 metres when not fully clear of SAVS FINALE (Chelsea Baker) causing that rider to check her mount. Checked near the 100 metres when DUNBRODY POWER shifted out marginally and PEACE BE UPON HIM shifted in carrying HEZREDHOT inwards onto JOHNNY CHUTZPAH.

**HEZREDHOT** – carried in onto JOHNNY CHUTZPAH by PEACE BE UPON HIM at about the 100 metres.

**PEACE BE UPON HIM** – Rider A Darmanin was reprimanded under AR 131(a) careless riding in that he allowed his mount to shift in when not sufficiently clear of HEZREDHOT (S Carr) causing that horse to be carried inwards towards JOHNNY CHUTZPAH causing rider B Muhcu to check his mount at about the 100 metres.

**PRISTINE IMAGE** – Raced three wide throughout.

**THOUGHTS'N'PRAYERS** – Over raced in the early and middle stages, laid in at the top of the straight.

**NEV'S BOY** – Raced three wide throughout.

**IRIS WEST** – Over raced in the early stages.

#### **RACE 7 – RAINE & HORNE SORELL CLASS 1 HCP (1200 METRES)**

**CORNELIAN BAY** – Difficult to load, pulled hard in the early stages.

**TARKINE EAGLE** – Rider T Baker advised stewards that in his opinion the gelding may have choked down in the run. A post race veterinary examination revealed no apparent abnormalities. Trainer T Mollross advised stewards it was her intentions to have blood tests taken.

**SHARE THE GOLD** – Fractious and reared in the barriers.

**ANOTHER PREDICTION** – Jumped outwards and bumped with TARKINE EAGLE.

**MAGIC TYPHOON** – Raced wide throughout.

**SHAMZOU** – Over raced and raced wide throughout.
