Cape Fernando underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to trainer Mr D Howlin in relation to Cape Fernando's racing manners, in particular, approaching the first turn. Acting on their own observations, viewing the official replays, and taking evidence from Mr Howlin. Stewards were of the opinion, that Cape Fernando had turned its head outwards and had made head and muzzle contact with Buckle Up Kenzie, and by doing so had marred the running of that greyhound pursuant to GAR123. Acting under the provisions of GAR127(b), Cape Fernando, has been stood down from racing for a period of 28 days at all tracks, and until the completion of a satisfactory trial.
