Acting on their own observations, taking evidence off Mr Pearce and viewing the official patrol film, Stewards were of the opinion that Special Bond had attempted to get wider on the track in the home straight and bumped with a runner to its outside resulting in the greyhound’s head being turned outwards momentarily. Stewards placed a warning on the

race manners of Special Bond and advised Mr Pearce that Stewards will closely monitor the racing manners of the greyhound in future events.
