Acting on their own observations and viewing the official patrol films, stewards were satisfied that as a consequence, no greyhound had been inconvenienced, so as to affect the outcome of the Event and gave all clear on the judges' numbers.

### **GENERAL**

Roxy Danger completed a stewards' trial as it was stood down from racing at the Launceston Greyhound Racing Club meeting on the 7<sup>th</sup> of November 2022 for marring pursuant to GAR127(b) and for approval to wear blinkers pursuant to GAR91(1). Weighing 28.9 kilograms and beginning from box 3 Roxy Danger completed the 278-metre trial distance in a time of 16.06. Roxy Danger has been cleared to race at all tracks and approved to wear blinkers in future events.

Buckle Up Lila completed a stewards' trial as it was stood down from racing at the Launceston Greyhound Racing Club meeting on the 31<sup>st</sup> of October 2022, for failing to pursue by reason of injury pursuant to GAR125(1)(a). Weighing 26.8 kilograms and beginning from box 3, Buckle Up Lila completed the 278-metre trial distance in a time of 16.20. Buckle Up Lila has been cleared to race at all tracks and up to 278m at LCN.

Speedy Noodle completed a stewards' trial as it was stood down from racing at the Launceston Greyhound Racing Club meeting on the 6<sup>th</sup> of December 2022 for marring pursuant to GAR127(a). Weighing 27.4 kilograms and beginning from box 3, Speedy Noodle completed the 278-metre trial distance in a time of 16.52. Speedy Noodle has been cleared to race at all tracks and up to 278m at LCN.
