### **GENERAL**

Baroque Serve completed a stewards' trial over the 461-metre trial distance pursuant to GAR123 for Marring on the 3<sup>rd</sup> of November 2022 at the Hobart Greyhound Racing Club meeting. Weighing 29.4 kilograms and beginning from box 5. Baroque Serve completed the 461-metre trial distance in a time of 26.77. Baroque Serve has been cleared to race at all tracks.

Fawn Shadow completed a stewards' trial over the 461-metre trial distance pursuant to GAR124 for Failing to Pursue on the 3<sup>rd</sup> of November 2022 at the Hobart Greyhound Racing Club meeting. Weighing 32.9 kilograms and beginning from box 5. Fawn Shadow completed the 461-metre trial distance in a time of 26.37. Fawn Shadow has been cleared to race at all tracks.

Stewards inquired into the conduct of Trainer Ms K Gregory in regard to the language used towards Trainer Mr M Pearce after the conclusion of Race 5. After hearing evidence from Ms Gregory and Mr Pearce, Stewards issued a charge to Ms Gregory pursuant to GAR156(f)(ii) for misconduct in that she used inappropriate language at Mr Pearce in the presence of other licenced participants and officials which in the opinion of Stewards constitutes misconduct. After hearing submissions on penalty, Stewards issued a Reprimand. In determining penalty, Stewards took into account Ms Gregory guilty plea, exemplary record under this rule and her time in the industry, however Stewards cannot condone this type of conduct from licenced participants for any reason whatsoever.
