Stewards reviewed an incident that occurred approaching the home turn, where it appeared that Just Like Jazzy may have turned its head outward momentarily. Upon reviewing the replays, it was determined Just Like Jazzy was galloped on and was subsequently checked, resulting in the greyhound becoming unbalanced on the point of the turn. Consequently, no action was taken. A post-race swab sample was taken from Disco Dance.
