Acting on their own observations and viewing the official replays, Stewards were of the opinion that Baroque Serve had turned its head outwards approaching the winning post and made head and muzzle contact with Allan Coe, and by doing so marred the running of that greyhound pursuant to GAR123. Acting under the provisions of GAR127(b), Baroque Serve has been stood down from racing for a period of 28 days, and until the competition of a satisfactory trial. Wiliann's Way underwent a post-race veterinary examination, and was found to have a dislocated toe to the left fore. Wilann's Way has been stood down from racing for a period of 28 days.
