Just Casper has been stood down from racing for a period of 3 days. Roxy Danger underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to Trainer Mr A Clark in relation to the race manner of Roxy Danger in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Clark Stewards were of the opinion that Roxy Danger had turned its head outwards towards Miss Piccolo in the home straight and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR124(1). Acting under the provisions of GAR127(a) Roxy Danger has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial.
