Stewards spoke to trainer Glenn Howlett in relation to the racing manners of Move Your Feet, in particular as the field raced into the home straight. Acting on their own observations, viewing the official replays and taking evidence from Trainer Glenn Howlett, Stewards were of the opinion that Move Your Feet had turned its head outwards towards another runner and in doing so had failed to pursue the lure with due commitment throughout the event, pursuant to GAR 124(1). Move Your Feet has been stood down for a period of 28 days at all tracks and the completion of a satisfactory trial.

Scraps Ahoy underwent a post-race veterinary examination, and no injury could be detected.
