Comments / Explanations:

RACE 1 – THE HON. ELISE ARCHER MP CLASS 1 HCP -- (1400 Metres)

BANCA TOM – Rider Erica Byrne Burke was fined the sum of \$300 under AR 132(7)(a)(ii) for using her whip 10 times prior to the 100 metres. She was also reprimanded under 132(7)(a)(ii) for using her whip in consecutive strides on one occasion.

MADETOBEBROKEN –Raced three-wide throughout. Shifted out under pressure near the 100 metres checking SCARDAMALIA between it and PRINCESS TINA which was inclined to lay in. Apprentice C Baker was reprimanded under AR 131(a) for careless riding, in not taking more severe action it was noted that Miss Baker had attempted to correct the shift from her mount.

SCARDIMALIA – Checked approaching the 100 metres between PRINCESS TINA and MADETOBEBROKEN when that gelding shifted ground outwards.

CORONATION VERONIC – Apprentice C Jordan reprimanded under AR 131(b) for failing to ride her mount out fully to the line.

PRINCESS TINA – Inclined to lay in over the concluding stages.

SALLY SUNSHINE – Bounded on jumping and was slow to begin.

VIVRE IS THE WORD – Rider S Tsaikos was fined \$100 under the provisions of AR 132(7)(a)(i) for using his whip on one occasion in consecutive strides prior to the 100 metres.

ANGELIC AMOUR – Stewards granted permission for rider B Neto to ride 1kg over the allocated minimum weight. Steadied off the heels of WEALLSTUCKATHOME near the 1000 metres when racing in restricted room to the inside of SCARDAMALIA. A post-race veterinary examination revealed a slow recovery rate. Trainer J Luttrell advised the gelding will be retired.

RACE 2 - NORTH HOBART MCDONALD'S MAIDEN - (1400 METRES)

AURUM MAN (NZ) -Slow to begin.

AUSSIE WARRIOR –Slow to begin. Shifted in near the 100 metres carrying AURUM MAN in onto ARELIUS which in turn tightened I'M KEEFE. Rider C Atkinson was advised to exercise more care when his mounts shift ground.

CONUMDRUM –A warning was placed on the gelding's barrier manners for being fractious in the gates. Raced wide throughout. Steadied over the heels of RUE DE PALAIS near the 150 meters.

ARELIUS –Tightened near the 100 metres.

GRAND PEGASUS – A post-race veterinary examination revealed no obvious abnormalities.

I'M KEEFE - Tightened near the 100 metres.

RUE DE PALAIS – Shifted in near the 150 metres tightening CONUMDRUM which had to be eased. Rider T Baker was reprimanded under AR 131(a) for careless riding.

GONE GLOBAL – Rider T Hope reported the mare failed to respond to her riding in the home straight. A post-race veterinary examination revealed no obvious abnormalities

LAKE MARGARET – A post-race veterinary examination revealed no obvious abnormalities.

NOXIOUS – Shifted out near the 200 metres and tightened the running of GONE GLOBAL. Rider M Ulucinar was reprimanded under the provisions of AR 131(a) for careless riding.

RACE 3 – LADBROKES MATES MODE BM70 HCP – (1600 METRES)

CHRISTOPHER ROBIN –Checked at the start and lost its position when RUBBLEONTHEDOUBLE shifted out abruptly. Laid in over the concluding stages.

DANTES (NZ) – Raced three-wide throughout.

MOVE LIKE JAGGER – Laid out throughout.

LORDOSIS - Tightened on jumping between VOLKANOWSKI and PRINCESS MAT

RUBBLEONTHEDOUBLE – Shifted out abruptly away from DANTES at the start carrying CHRISTOPHER ROBIN out and checking it.

TRABZON – Held up for a clear run on the home turn.

PRINCESS MATOAKA –Held up for a clear run on the home turn.

TOOL STEEL –Slow to begin. A post-race veterinary examination revealed the gelding to have blood in the mouth from an old injury site.

RACE 4 - WINNING EDGE PRESENTATION MDN/CL1 - (1600 METRES)

CHARLIE BUCKET –Bucked after the start. The gelding has been stood down from racing until it trials satisfactorily.

JACKJACK – Checked shortly after the start when tightened by CHARLIE BUCKET which was bucking.

KATZENJAMMER –Hung out after the start and checked SHAMZOU.

SHAMZOU –Checked after the start by KATZENJAMMER shifting out.

SMOKIN' HARD – Slow to begin.

VANITY STAR –Slow to begin. Held up for a clear run near the 250 metres and again near the 100 metres.

ZOU ZOU –Compounded over the concluding stages. A post-race veterinary examination revealed a slow recovery rate.

RACE 5 – DEAN WINTER MP BM62 HCP – (2100 METRES)

GEE GEE ENUF SPEED – Crowded for room near the 1900 metres when AMERICAN JEWEL shifted in.

TRUE SCOTSMAN (NZ) – Rider A Darmanin was reminded of his obligation to ride his mounts out fully to the finish.

NOZTRABEEL – Compounded over the concluding stages. A post-race veterinary examination revealed no obvious abnormalities.

JOHN'S LAD - A post-race veterinary inspection revealed no obvious abnormalities.

AMERICAN JEWEL – Shifted in near the 1900 metres when not fully clear of GEE GEE ENUF SPEED which had to be steadied. Rider D Parish was reprimanded under AR 131(a) for careless riding.

RACE 6 - GRAHAM FAMILY FUNERALS THOMAS LYONS STAKES - (1400 METRES)

THE INEVITABLE – Laid in over the concluding stages.

BLAZE FORTH – Over raced near the 1200 metres

FIRST ACCUSED - Steadied off the heels of SIR SIMON near the 600 metres.

ALPINE WOLF –Steadied off the heels of REBEL FACTOR near the 800 metres.

SIR SIMON –Slow to begin, then elected to race wide and progress to the lead. Shifted in near the 800 metres and again near the 600 metres. FIRST ACCUSED eased of the heels of SIR SIMON near the 600 metres Apprentice C Baker was advised to ensure she is fully clear before crossing.

REBEL FACTOR – Steadied off the heels of SIR SIMON near the 800 metres. Rider B McCoull reported he felt the gelding's galloping action was not consistent with previous starts and he did not respond to his riding from the 600 metres. A post-race veterinary examination revealed no abnormalities.

JUST A TRIBUTE -Slow to begin.

DARK WANDERER -Tightened shortly after the start when FIRST ACCUSED shifted in.

RACE 7 BIG4 ILUKA ON FREYCINET BM72 HCP - (1100 METRES)

ALGERNON – Raced wide throughout. Apprentice E Byrne Burke was fined the sum of \$500 under the provisions of AR 132(7)(a)(ii) for using her whip 9 times prior to the 100 metres. A post-race veterinary examination revealed a poor recovery rate.

OUTBOUND – Slow to muster early speed.

RACE 8 - LADBROKES HOBART CUP - (2400 METRES)

SPIRIT RIDGE (GB) - Raced wide from the 1300 metres.

SWOOP DOG – Compounded over the concluding stages.

GLASS WARRIOR – Raced wide from the 1,000 metres and carried wider near the 600 metres when DARK DREAM shifted wider.

WHITE HAWK – Underwent a pre-race veterinary examination and passed fit to compete.

RISING LIGHT - Apprentice E Byrne Burke pleaded guilty to using her whip 9 times prior to the 100 metres under the provisions of AR 132(7)(a)(ii). After consideration of all relevant factors Ms Byrne-Burke was fined \$800.00.

DRAMAZING – Shifted in approaching the winning post tightening the running of I'M SO COOL rider A Darmanin was advised to exercise more care when allowing his mounts to shift ground.

TRAVELLING GIGOLO – Laid in under pressure in the home straight.

I'M SO COOL – Hung out making the home turn. Compounded in the home straight. Tightened near the winning post on the final occasion.

STEEL SKIES – Change of tactics advised that circumstances permitting they will attempt to ride the gelding further forward. Slow to begin.

RACE 9 - LADBROKES PUNTER ASSIST BM62 HCP - (1400 METRES)

BRINKTOP LAD – Raced three-wide throughout.

FREAK ON A LEAD – Shifted in under pressure near the 100 metres checking RICH CLAN. Stewards found Apprentice E Byrne Burke guilty of careless riding under the provisions of AR 131(a). After taking into account submissions on penalty including her good record her licence to ride in race was suspended for 1 Tasmanian race date to commence at midnight on Wednesday 22nd February 2023 and expiring at midnight on Wednesday March 1st 2023.

RICH CLAN – Checked near the 100 metres when FREAK ON A LEAD shifted in.

STEALLADONI –A post-race veterinary examination revealed no obvious abnormalities.

MR FREEZE – Steadied off heels shortly after the start.

HELLOT – Held up for a clear run near the 200 metres.

ZADE'S STORIES – A post-race veterinary examination revealed no obvious abnormalities.
