Lil Miss Tegan underwent a post-race veterinary examination which revealed fracture to the left hind lateral toe. Lil Miss Tegan has been stood down from racing for a period of 40 days. Stewards spoke to Trainer A Bullock in relation to the racing manners of Lil Miss Tegan. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Lil Miss Tegan had marred over the concluding stages of the event. Pursuant to GAR127(a), Lil Miss Tegan has been stood down from racing at the Launceston track for a period of 28 days and until the completion of a satisfactory trial.
