### Comments / Explanations:

*Rider H McCarthy was indisposed for this meeting due to a trackwork incident and has been advised that a medical clearance will be required prior to next riding.*

### **RACE 1 – THANK YOU PETER STAPLES MAIDEN – (1400 METRES)**

**BALCASKIE** – Over raced early and middle stages and raced three wide throughout. Laid in approaching the 200 metres and rider D Pires had to stop and straighten his mount.

**FOREIGN LEGION** – Slipped behind on jumping and shifted inwards, over raced in the early stages.

**SCANDALOUS AFFAIR (NZ)** – Lost both hind plates in the run.

**VELOCE AQUILA** – Tightened at the start between FOREIGN LEGION and FALCULA.

**FALCULA** – Shifted out at start tightening VELOCE AQUILA.

### **RACE 2 – TASMANIAN BLOODSTOCK MAIDEN – (1200 METRES)**

**FREDDY'SAJETSTAR** – Restrained and lost its position near the 200 metres. Lost an off fore plate in the run.

**GEEGEE'S ROYAL DUKE** – Slow to begin.

**GEEGEE'S SHOWTIME** – Declared a late scratching at 12.13pm on veterinary advice after breaking free from the attendants and galloping back to the mounting yard. On the announcement of correct weight Stewards ordered that all monies invested on GEEGEE'S SHOWTIME to be refunded, with the following deductions to apply to successful wagers placed prior to 12.13pm. Trainer L Wells was advised that the colt must complete a satisfactory trial prior to racing again.

Deductions

(1st) MOVEFORLEX – 5 cents a win & 2 cents a place

(2nd) GRAND AQUILA – 10 cents a place

(3rd) BELLASARIO – 9 cents a place

All monies bet after the withdrawal to be paid at face value of the ticket.

**GEEGEE'S SUNSHINE** – shifted out at about the 200 metres carrying MOVEFORLEX wider.

**GRANDE AQUILA** – Shifted out on jumping and bumped with TOUGH IMPACT, shifted out under pressure approaching the 100 metres carrying MOVEFORLEX wider.

**MOVEFORLEX** – Raced three wide throughout, carried wider near the 200 metres by GEEGEE'S SUNSHINE.

**ZULU ESPRIT** – **Fractious** in barriers prior to the start and was slow to begin.

**LORI LEE** – Placed in restricted room at about the 800 metres when the pace slackened.

**SHAMMGOD (NZ)** – Over raced approaching the 400 metres, held up rounding the home turn until shifting wider for a clear run.

**BELLASARIO** – Raced wide throughout.

**TOUGH IMPACT** – Raced four wide to the 600 metres.

Rider C Wells (GEEGEE SUNSHINE) was reprimanded under the provisions of AR131(a) for allowing her mount to shift out at about the 200 metres carrying MOVEFORLEX wider, resulting in FREDDY'SAJETSTAR being restrained by its rider and losing its position. In not taking further action stewards were mindful that there was a marginal shift by BELLASARIO which was racing to the outside of FREDDY'SAJETSTAR.

### **RACE 3 – LADBROKE IT! MDN/CL1 – (2100 METRES)**

**CHI MAZEL** – Jumped inwards at the start, over raced early stages.

**LAUNNIE NIGHTS** – Held up rounding the home turn and until obtaining a clear run at about the 250 metres.

**LADY VUITTON** – Underwent a pre-race veterinary examination after sustaining a minor abrasion to the front of the off-hind cannon enroute to the course and was passed fit to take its place in the field.

**PREWINGO** – Raced three wide throughout.

**PUMA** – Stewards granted permission for rider J Maskiell to ride 1kg over the allotted weight.

**MISS PEBBLES** – Stewards granted permission for rider M Ulucinar to ride 1kg over the allotted weight. Had a tendency to lay in under pressure in the home straight.

**SHAKEEDA** – Held up momentarily entering the home straight.

### **RACE 4 – AVISO TAS INSURANCE BROKERS TASMANIAN SIRES PRODUCE – (1400 METRES)**

**GEEGEESDOWN SOUTH** – Raced three wide throughout.

**BOBBLE** – Slow to begin 1 to 2 lengths.

**PEROLA** – Over raced early stages.

**KEYS CLAN** – Slow to begin 2 to 3 lengths.

### **RACE 5 – VALE MILTON PETTIT BM68 – (1200 METRES)**

**GEEGEELUCKYSTAR** – Shifted out under pressure from about the 150 metres.

**MULTISANTI** – Dipped on jumping. Stewards queried rider B McCoull in relation to the below market expectations of the gelding. Rider B McCoull stated that the gelding felt uncomfortable in the run and that his mount had dipped in the run on a number of occasions. A post race veterinary examination failed to reveal any abnormalities.

**SHARMA RAMA** – Jumped awkwardly at the start.

**GEE GEE TRUE STORY** – Raced three wide throughout.

Rider C Wells (**GEEGEELUCKYSTAR**) pleaded guilty to a charge under the provisions of AR210(1) for failing to weigh in. Stewards in delivering penalty took into account her guilty plea and circumstances surrounding returning to scale. Rider C Wells was fined the sum of \$200.

### **RACE 6 – VALE DEAN HOLLAND CLASS 1 HCP – (1200 METRES)**

**DANTES** – Laid in under pressure in the home straight.

**EXPENSIVE MISTAKE** – Lost front near side plate in the run.

**RICHMOND POET (NZ)** – Bounded out on jumping and was slow to begin.

**DUMPUS** – Inconvenienced at the start and shifted out bumping with GEE GEES CHORUS shortly after.

**SHIM** – Slow to begin, disappointed for a clear run from the home turn until about the 200 metres and then obtained a clear run when shifting wider.

**TARKINE EAGLE** – Raced wide throughout.

**GEE GEES CHORIS** – Bumped with DUMPUS becoming unbalanced for a stride shortly after the start.

**GRAPHITE MIST** – Raced three wide throughout.

**DAWN EAGLE** – Shifted out to improve on the home turn resulting in DUMPUS shying away and out onto OLE OLA.

### **RACE 7 – KEVIN SHARKIE 3YO AUTUMN CLASSIC – (1400 METRES)**

**GEEGEES GEMSTONE** – Stewards queried rider S Carr in relation to the below market expectations of the gelding. Rider S Carr stated that when placing the gelding under pressure it failed to respond to her riding. Raced three wide throughout and over raced in the early stages. A post race veterinary examination revealed slow recovery rate with a very high heart rate.

**FURNEAUX** – Over raced early stages.

**GALAN** – Slow to begin.

**BUEL** – Slow to begin.

**AUNTIE JAKE'S BAR** – Slow to begin, raced four wide throughout.

Rider L Annells (**BUEL**) pleaded guilty to a charge under the provisions of AR 132(7)(a)(ii) for using her whip 11 times prior to the 100 metres. In determining penalty stewards took into

account her guilty plea and her record in relation to this rule. Rider L Annells was fined the sum of \$600.

### **RACE 8 – WINNING EDGE PRESENTATIONS 0 – 62 – (1400 METRES)**

**MYOCARDIUM** – Raced wide throughout.

**HELLOT** – Stewards queried rider D Pires in relation to the below market expectations of the gelding. Rider D Pires stated that he elected to go back from a wide barrier and he believed the track was leader biased and the early and middle pace didn't suit.

**ETOSHA** – Trainer T Evans advised stewards of change of tactics and advised intentions to race on pace and not lead circumstances permitting. Rider H Le Blanc advised that the gelding hung out throughout and after jumping exceptionally well she was left in a position where she then elected to lead despite the advised change of tactics.

**DUTCH ACTION** – Slow to begin.

**GEE GEE RHYTHM** – Over raced middle stages.

**KITTY PURRING** – Raced wide throughout.

**GEE GEE SILENTNITE** – The tongue tie was adjusted behind the barriers prior to the start. Held up for a clear run at about the 250 metres.

### **RACE 9 – CANADIAN CLUB BM72 HCP - (1100 METRES)**

**ROMARY** – Harmlessly dislodged rider C Wells enroute to the barriers. Rider C Wells was examined by medical staff and cleared to fulfill her riding engagement. Raced three wide to the 600 metres.

**WARDELL** – Rider B McCoull advised stewards that the gelding hung out throughout.

**ALPINE AFFAIR** – Slow to begin.

**GEE GEE MISS QUITA** – Rider S Carr pleaded guilty to a charge under the provisions of AR 132(7)(a)(ii) for using her whip 9 times prior to the 100 metres. In determining penalty stewards took into account her guilty plea and her record in relation to this rule. Rider S Carr was fined the sum of \$300.

#### **RACE 6 – GREAT NORTHERN BM62 HCP 1350 METRES**

Stewards concluded an inquiry into the reasons DARGO (S Carr) was checked and inconvenienced approaching the first turn. It was established that shortly after the start SKILENDRA had got its head up and shifted in due to the saddle slipping on the mare placing rider C Baker in a difficult position of controlling her mount. It was also noted that the saddle slip placed rider C Baker at a disadvantage throughout the race.
