Stewards spoke with trainer Mr W Howells via mobile phone in relation to the race manners of Shanghai Violet, in particular approaching the first turn. After viewing the official patrol films and speaking with Mr W Howells Shanghai Violet was issued a charge under the provisions of GAR124 for failing to pursue the lure with due commitment. Stewards were of the opinion that Shanghai Violet had visibly eased free of interference. Due to Mr W Howells leaving the racecourse, Stewards offered Mr W Howells the opportunity for the greyhound to undergo a veterinary assessment if he returned to the course, however, the offer was refused. Shanghai Violet has been stood down from racing for a period of 28 days Hobart only. A post race swab sample was taken from Ahsoka Tano, winner of the event.

### **General**
