Litigate underwent a post-race veterinary examination which revealed a fractured hock on the right hind leg. Litigate has been stood down from racing for a period of 60 days. Smoke Show underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to trainer representative Mr M Stringer in relation to Smoke Show's racing manners, in particular in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Stringer, Stewards were of the opinion that after bumping with Rojo Diamond, Smoke Show had turned its head outwards momentarily whilst being unbalanced. No action was taken, other than a warning being placed on the greyhound.
