Comments / Explanations:

Trainer A Duggan was fined the sum of \$50 under the provisions of LR13.3 for the late rider declaration for FREDDY'SAJETSTAR in Race 3.

Trainer A Duggan was fined \$50 under the provisions of AR194 for being late into the mounting yard in race 7 with SPEED ROCK.

Random urine samples were taken from two riders.

RACE 1 – LINDISFARNE AFL MASTERS BM76 HCP – (1600 METRES)

ALPINE AFFAIR – Rider A Darmanin dropped his whip at about the 50 metres.

GEE GEE MISS QUITA – Momentarily held up rounding the home turn.

STELLADONI – Re-saddled behind the barriers prior to the start.

RACE 2 – WELLINGTON CRICKET CLUB MAIDEN – (1600 METRES)

BALCASKIE – Rider D Pires dropped his whip on entering the home straight.

BINGO WAS HISNAMEO – Raced wide throughout without cover. A post-race veterinary examination failed to reveal any obvious abnormality.

FALCULA – Raced wide throughout with cover.

MISS PEBBLES – Raced ungenerously in the middle stages.

SHAKEEDA – Over raced in the early stages.

HEWIE – Had a tendency to lay in, in the home straight.

Rider B McCoull (HEWIE) pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) for using his whip on 9 occasions prior to the 100 metres, four more than permitted. In assessing penalty stewards took into account his guilty plea and his record in relation to this rule and that he had won the race. Rider B McCoull was fined the sum of \$300.

RACE 3 – RACING CRICKET CLUB MAIDEN – (1600 METRES)

FREDDY'SAJETSTAR – Raced three wide throughout.

GEEGEE'S ROYAL DUKE – Slow to begin.

GEEGEE'S SUNSHINE – Raced wide throughout, restrained off heels of TOOL STEEL entering the home straight, held up for a clear run for a major part of the home straight.

JAGGER ROCKS – Slow to begin.

CLOVER HILL – Raced wide throughout.

CORONATION ALLY – Held up behind AGNETE until about the 150 metres when obtaining a run to the outside of AGNETE.

MISS CHICA MALA – Bounded out on jumping and then shifted in.

SHAMMGOD (NZ) – Held up early in the home straight and shifted wider to be obtain a clear run at about the 250 metres.

SIRENE'S LILLY – Raced wide throughout, Rider D Pires dropped his offside rein entering the home straight.

TOOL STEEL – Raced wide throughout, had a tendency to lay in, in the home straight.

I'M KEEFE – Shifted out after jumping, raced wide throughout, had a tendency to lay in, in the home straight.

CHRISTOPHER ROBIN – Inconvenienced at the start when MISS CHICA MALA shifted in.

RACE 4 – HAPPY MOTHER'S DAY BM68 HCP – (2100 METRES)

CYCLONE LOUIE – Raced three wide throughout.

MAARKLE – Slow to begin, over raced early and middle stages.

BANCA GLEE – A post-race veterinary examination failed to reveal any obvious abnormality.

AFRIDI (NZ) – Bounded out on jumping and was slow to muster early speed, lost an off fore shoe in the run.

Rider A Darmanin (LADY VUITTON) pleaded guilty to a charge under the provisions of AR132(7)(a)(i) for using his whip on consecutive strides prior to the 100 metres. Rider A Darmanin was fined \$100.

Rider S Carr (COSTERO) pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) in that she used her whip on 10 occasions prior to the 100 metres, which is five more than permitted. In assessing penalty stewards took into account her guilty plea, her record in relation to this rule and that it was a high breach. Rider S Carr was fined the sum of \$600.

RACE 5 – AYC NETBALL CLUB CLASS 1 HCP – (1200 METRES)

DUMPUS – Over raced middle stages.

I'M KRUPT – Shifted in after jumping crowding ROWDY GIRL. Raced wide throughout, shifted out under pressure over the concluding stages.

SHIM – Shifted wider to improve to the outside of ZULU GURU at about the 250 metres.

MILLA'S READY – Held up behind ZULU GURU at about the 400 metres.

ZULU GURU – A post-race veterinary examination failed to reveal any obvious abnormality.

ROWDY GIRL – Restrained off heels of I'm Krupt shortly after the start. A post-race veterinary examination failed to reveal any obvious abnormality.

RACE 6 – LADBROKES RACING CLUB OPEN HCP – (1200 METRES)

JOHNNY CHUTZPAH – Laid in, in the back straight and raced wide throughout. Had a tendency to lay in on entering the home straight.

RACE 7 – KEVIN SHARKIE 3YO CLASS 1 HCP – (1400 METRES)

AFRICAN THUNDER – Over raced early stages, restrained off heels at about the 600 metres.

RICHMOND POET (NZ) – Fractious in barriers prior to start, jumped inwards tightening FIGHTING GRACE. Stewards advised rider B Muhcu to exercise care when allowing his mount to lay in when approaching the 600 metres, tightening the run of AFRICAN THUNDER which had to be restrained by its rider.

EXPENSIVE MISTAKE – Saddle was adjusted prior to the start behind the barriers. Rider G Catania advised Stewards that the saddle had slipped at the top of the straight, placing her at a disadvantage. Ms Catania also stated the gelding failed to run on. A post-race veterinary examination failed to reveal any obvious abnormality.

OLE OLA – Laid in for a major part of the home straight and had to be straightened by its rider on a number of occasions.

MARTINI BLUE – Raced wide throughout.

TARKINE EAGLE – Got its head up when restrained off heels at the 600 metres.

KRUPT CANDY – Rider L Annells reported that the tongue tie had come off during the race.

FIGHTING GRACE – Inconvenienced at the start and was slow to begin.

RACE 8 – HOBART UNITED FC BM68 HCP – (1400 METRES)

EAGLE STREET – Slow to begin 1L. Stewards spoke to rider D Pires in relation to the below market performance of the gelding, noting that it was the favourite. Rider D Pires stated that in his opinion the horse started to lay out rounding the home turn and that he restrained momentarily to attempt to maintain his position and stop the gelding from laying out onto IVORYMAN. It was also in his opinion the gelding finished off strongly and would be better suited over 1600 metres.

PRISTINE IMAGE – A post race veterinary examination revealed a high heart rate slow recovery.

POPEYE THE SAILOR – Raced wide throughout.

RACE 9 – LADBROKES IT! BM60 HCP – (1100 METRES)

NICCO THE GREEK – Laid in for a major part of the home straight.

TONY NICCONI – Raced wide to the 600 metres.

DAWN PERFORMER – Raced wide to the 600 metres.

STEEL MIST – Slow to begin.

BARIA – Steadied off heels of MAGIC TYPHOON shortly after the start.

DAWN EAGLE – Approaching the 200 metres shifted out over the heels of SHARMA RAMA to improve.

FANCIFUL FLYING – Raced wide throughout.

MAGIC TYPHOON – Shifted out shortly after the start resulting in BARIA having to steady off heels, hung out from the start to the 400 metres. A post-race veterinary examination failed to reveal any obvious abnormality.
