## Comments / Explanations:

Random urine samples were taken from two riders.

Rider A Darmanin was indisposed due to flight cancellations.

Rider H Le Blanc was replaced in races 1 and 2 due to her flight being delayed.

Trainer S Brunton was fined \$200 under the provisions of AR16(b)(iii) for engaging a rider who was declared to ride EAGLE STREET in Race 6 and was subsequently substituted as they were unable to make the declared riding weight.

### RACE 1 - MCDONALDS NORTH HOBART MAIDEN - (1200 METRES)

**SWEET LUCIFER –** Checked at the start between A LITTLE SHADY and CROWN AND ANCHOR both of which shifted ground. Raced three-wide, bumped and carried wider near the 700 metres. Laid in over the concluding stages.

A LITTLE SHADY - Shifted in on jumping.

**CORONATION ALLY –** Slow to begin, slow to muster early speed.

**GLOBAL AWARNESS** – Slow to begin.

**GONE GLOBAL** – Declared a late scratching at 11.56am when the mare could not be loaded. Stewards advised trainer T Keys that GONE GLOBAL must complete two satisfactory official trials in succession prior to being permitted to race again.

On the announcement of correct weight stewards ordered that all monies invested on GONE GLOBAL be refunded, with the following deductions to apply to successful wagers placed prior to 11:56am.

Stewards ordered all bets place on GONE GLOBAL to be refunded in full, with the following deductions.

1st Creative Licence 4c Win 7c place

2<sup>nd</sup> Lordosis 5c place 3<sup>rd</sup> Thespian Waters 4c place

All monies bet after the withdrawal to be paid at face value of the ticket.

**SHAMMGOD (NZ) –** Over raced near the 700 metres and had to be checked off the heels of CORONATION ALLY, held up near the 150 metres.

**WE ALL DECIDE** – Declared a late scratching at 8.55am on veterinary advice after confirmation from trainer S Cotton that the filly had nasal discharge in both nostrils. Trainer S Cotton was advised a veterinary clearance would be required prior to racing.

**THESPIAN WATERS** –Slow to begin.

**LADY SARAH** – Over raced near the 700 meters and shifted out bumping with SWEET LUCIFER.

**CROWN AND ANCHOR –** Over raced in the early stages.

#### RACE 2 – LADBROKES OWNERS INCENTIVE CLASS 1 HCP – (1200 METRES)

**BERSERKER** – Bumped with MILLA'S READY at the start. Raced three wide without cover. Shifted in over the concluding stages and brushed with PERKINS.

**CHORIZAMA** – Bumped at the start by VOLKANOVSKI, which was then carried in bumping with SHIM. Rider E Byrne Burke reported she felt something amiss in the gelding's action from the 600 metres. A post-race veterinary examination revealed no obvious abnormalities.

**VOLKANOVSKI** – Jumped awkwardly and made contact with the inside barrier gate, bumped with CHORIZAMA shortly after.

**HER THOUGHTS** – David Pires was reprimanded under AR 131(b) for failing to ride his mount out fully to the finish. In not taking further action Stewards were mindful that rider D Pires had not lost his position at the end of the race.

**PERKINS** – Stewards granted permission for rider H McCarthy to ride 1kg over the allotted weight due to rider availability. Raced in restricted room approaching the winning post.

**SALLY SUNSHINE** – Tightened on jumping by SAXON MIST shifting in and was slow to begin.

MILLA'S READY - Bumped with BERSERKER at the start.

**SHIM** – Bumped by CHORIZAMA shortly after the start.

Rider B McCoull (SHIM) pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) for using the whip on 9 occasions prior to the 100 metres. Four more times than permitted. In assessing penalty stewards took into account his guilty plea, his record in relation to this rule and that he had won the race. Rider B McCoull was fined the sum of \$600.

#### RACE 3 - WOMEN IN RACING MAIDEN - (1430 METRES)

**ARTFUL PEGASUS –** Raced three wide without cover to the 800 metres and then with cover thereafter. A post-race veterinary examination revealed no obvious abnormalities.

**MAY WE ALL –** Raced wide with cover throughout.

**SCANDALOUS AFFAIR (NZ) –** Over-raced in the early stages, raced wide throughout.

**ZULU ESPRIT** – Slow to begin. A post-race veterinary examination revealed no obvious abnormalities.

**EMMJAY –** Over raced in the early and middle stages.

**TOOL STEEL –** Raced four-wide to the 800 metres and then three wide thereafter without cover.

### RACE 4 - UP CUPS BM72 HCP - (2400 METRES)

**MAARKLE** – Raced wide throughout. A post-race veterinary examination revealed no obvious abnormalities.

**CHI MAZEL –** Blundered on jumping, over raced in the early stages.

### RACE 5 - LADBROKES RACING CLUB CLASS 1 HCP - (1600 METRES)

**DUTCH ACTION** –Slow to begin, over raced middle stages.

**EXPENSIVE MISTAKE** -Raced three wide without cover.

**DOONICAN** – Slow to muster early speed.

**ROWDY GIRL** – Held up for a clear run behind EXPENSIVE MISTAKE entering the home straight and again neat the 200 metres.

## RACE 6 - AVISO TAS PINK CUP - (1430 METRES)

**HELLOVA NIGHT –** Stewards queried the tactics adopted by apprentice C Van Munster with Senior rider S Carr in relation to leading the event by a considerable margin. Apprentice C Van Munster advised stewards that she had been instructed to lead however in retrospect had allowed the gelding to lead by too great a margin by allowing it to run freely in front. Stewards advised Ms Van Munster that she must ensure that she allows her mounts some respite in future when attempting to lead.

**MONMOUTH** – A post-race veterinary examination revealed no obvious abnormalities.

**FREAK ON A LEAD –** Raced three wide throughout.

**EAGLE STREET –** Slow to begin.

#### RACE 7 - KEVIN SHARKIE BM60 HCP - (1430 METRES)

**BANCA TOM –** Laid in over the concluding stages.

**IVORYMAN (NZ) –** Slow to begin.

**FAR AWAY HIT –** Jumped awkwardly, had a tendency to over race in the middle stages.

**ANONYMOUS SOURCE –** Bumped with OLE OLA at the start.

**OLE OLA –** Bumped with ANONYMOUS SOURCE on jumping. Over-raced in the middle stages.

**POWERFUL PEBBLES – Raced wide throughout.** 

#### RACE 8 – GRAHAM FAMILY FUNERALS BM68 HCP – (1100 METRES)

**GEEGELUCKYSTAR** – Apprentice C Baker was reprimanded under the provisions of AR 131(b) for failing to ride her mount out fully to the end of the race. In not taking further action Stewards were mindful that she had not lost her position at the end of the race.

**NICCO THE GREEK –** Laid in over the concluding stages.

**MOVE ON OVER –** Jumped awkwardly and made contact with the inside of the barrier gate, raced wide throughout.

**ETOSHA** – Shifted out on jumping.

**AMANCAYA –** Checked at the start when ETOSHA shifted out.

**NEED A FLUTTER –** Slow to begin (3L).
