### Comments / Explanations:

# RACE 1 - MORETON GROUP SOLUTIONS MAIDEN - (1430 METRES)

The photo finish failed to operate for the finish of this race.

**GEEGES SUNSHINE** – Raced three wide in the early stages. Apprentice T Johnstone reported that the gelding failed to respond to her riding in the home straight. A post-race veterinary examination failed to reveal any obvious abnormalities.

**LONDIANI –** Re-saddled behind the barriers, over-raced early stages.

**WADDY WADDY –** Bounded out on jumping and was slow to begin, got it's head up soon after and continued to over-race in the early stages.

**KNOT DANCING –** Race greenly throughout.

**MIRA FLORES** – Raced four wide early and then three wide from the 600 metres.

#### RACE 2 – LADBROKES MAIDEN BREAKTHROUGH BONUS MAIDEN (1100 METRES)

**CHRISTOPHER ROBIN –** Slow to begin, held up in the home straight

**FASHION FOX –** Jumped inwards at the start. Rider D Pires advised that his mount laid in throughout, raced wide throughout.

**FREDDY'SAJETSTAR** – Held up on the home turn and again in the home straight near the 200 metres and again near the 100 metres.

**LOUD MOUTH (NZ)** – Laid in when caught wide in the back straight and bumped with TULATI.

A LITTLE SHADY - Bounded out on jumping and was slow to begin.

**DING DING –** Appeared to clip heels of FASHION FOX shortly after the start and blunder.

**PASS US BY –** Bumped by TOOL STEEL at about the 900 metres.

**PROSPEROUS MISS** – Had a tendency to over-race in the early stages.

**ROLLING IN IT –** Raced wide to the 600 metres. Rider A Darmanin was severely reprimanded under the provisions of AR 131(a) for careless riding for allowing his mount to shift in near the 200 metres when not fully clear of A LITTLE SHADY which had attempted a tight run to the inside at this point. In not taking more severe action it was taken into account that he had been initially tightened by LOUD MOUTH which had laid in at this point. Momentarily tightened when LOUD MOUTH laid in near the 100 metres.

**TOOL STEEL –** Bumped with PASS US BY at about the 900 metres, shifted out abruptly at about the 700 metres.

**TULATI** – A post race veterinary examination revealed a slow heart rate recovery.

#### RACE 3 – TASMANIANIAN BLOODSTOCK 2YO & 3YO MAIDEN – (1200 METRES)

**LORDOSIS** – Rider D Pires reported his mount changed stride at the 600 metres and hung out thereafter. A post-race veterinary examination failed to reveal any obvious abnormalities.

**SHOOTING NORTH – Raced four wide to the 600 metres.** 

**ARAYA SUNSHINE** – Bumped and checked at the start when STEEL MY SUNSHINE shifted out on jumping.

**MISS DARKSIDE (NZ)** – Declared a late scratching at 12.38pm when the filly could not be loaded. MISS DARKSIDE has been stood down to an official trial. On the announcement of correct weight stewards ordered that all monies invested on MISS DARKSIDE be refunded, with the following deductions to apply to successful wagers placed prior to 12.38pm.

1st - BELLASARIO - 1c win and 2c place 2nd - MISS CHICA MALA - 2c place 3rd - THESPIAN WATERS - 2c place

All monies bet after the withdrawal to be paid at face value of the ticket.

**NOXIOUS –** Over raced in the early stages.

**STEELE MY SUNSHINE** – Bounded out on jumping and was slow to begin, soon after shifted out and bumped with ARAYA SUNSHINE.

**WE ALL DECIDE** – Raced very wide in the early stages, held up on the home turn.

**THESPIAN WATERS** – Jumped awkwardly and shifted in bumping with PENNINE, race five wide to the 600 metres.

**PENNINE** – Raced wide throughout.

**FLYING PARIAH –** Slow to begin.

#### RACE 4 – HOBART UNITED FOOTBALL CLUB 0-62 (1200 METRES)

**GEE GEES SO TRUE** – Held up momentarily for a clear run rounding the home turn. When questioned on the below market performance of the Apprentice T Johnstone stated after being held up the gelding failed to respond to her riding and she believed todays track conditions may not have been suitable.

**FURNEAUX** – Jumped very awkwardly and struck the outside barrier gate and then continued to shift out. A warning has been placed on the starting manners of the gelding. Raced wide throughout. Rider D Pires was examined by the on-course Doctor and medical staff and was passed fit to fulfill his remaining riding engagements.

**I'M KRUPT –** Apprentice L Annells was reminded of her obligation to ensure she rides her mounts out fully to the finish.

**BERRUTI** – Slow to begin.

**ZIAVERA** – Raced three wide throughout.

**VOLKANOVSKI** – A post-race veterinary examination revealed the gelding to have bled from one nostril. Acting under the provisions of AR 79 (8) the gelding has been stood down until it completes a satisfactory gallop of 1000 metres.

**DOMINATOR'S GIRL** –When questioned Bulent Muhcu stated the mare failed to respond to his riding from the 400 metres when placed under pressure.

**NEV'S BOY –** Bounded on jumping and was slow to begin.

**PERKINS** – raced wide throughout.

#### RACE 5 - KEVIN SHARKIE BM68 HCP - (1200 METRES)

Correct weight was delayed for Apprentice C Baker to view the official patrol film in the home straight. After viewing the official patrol films Apprentice C Baker was satisfied and correct weight was given on the judge's numbers.

**TSUNAMI SAM (NZ)** – Jumped out at the start and bumped with SHAMZOU. Shifted out near the winning post and tightened the running of MOVE ON OVER. Underwent a pre-race veterinary examination and was passed fit to compete after having tips placed on both front feet.

**BRINKTOP LAD –** Raced wide without cover throughout.

**MOVE ON OVER –** Blundered on jumping and tightened for racing room approaching the winning post.

**GEE GEE ENUF SPEED –** Bumped when MOVE ON OVER was carried outward approaching the winning post.

**SHAMZOU –** Bumped on jumping and then tightened between TSUNAMI SAM and GEE GEE ENUF SPEED.

#### RACE 6 - KEVIN SHARKIE MDN/CL1 (1600 METRES)

**DOONICAN (IRE)** – Restrained shortly after the start from the wide barrier.

**ARCUCCI** – Raced wide throughout.

**KING KURT** – Slow to begin and shortly after appeared to clip the hind leg of ROWDY GIRL and blundered.

**FALCULA** – Slow to begin.

**FIGHTING GRACE –** Raced wide throughout.

**WESTERN TEARS** – Over raced in the early stages.

**ROWDY GIRL** – Struck the outside barrier gate on jumping, shifted out and as a result KING KURT clipped its offside hind leg and blundered.

#### RACE 7 – LADBROKES RACING CLUB BM64 HANDICAP - (1600 METRES)

**EAGLE STREET –** Slow to begin, raced wide throughout, had a tendency to lay in, in the home straight.

**KING ISLAND** – Raced wide throughout. A post-race veterinary examination revealed a high heart rate slow recovery.

**JACKJACK** – Commenced to race fiercely entering back straight and shifted out and raced wide thereafter. Laid in, in the home straight, A post-race veterinary examination failed to reveal any obvious abnormalities.

**OLE OLA** –Fractious in the barriers and underwent a pre-race veterinary examination and passed fit to compete. Held up from the 500 metres until the 400 metres.

#### RACE 8 – AVISO TAS INSURANCE BROKERS CLASS 3 HCP – (1430 METRES)

**NICCO THE GREEK –** Raced wide throughout.

**STEEL MIST** – Raced wide in the back straight and Apprentice C Van Munster stated that after being back early she elected to improve her position however the gelding commenced to over-race and the decision to go forward was adopted.

**SHIM** – When questioned on the below market expectations performance rider A Darmanin stated that the filly failed to respond to his riding in the home straight and may have come to the end of its preparation. A post-race veterinary examination revealed the mare to be heavily in season.

**AMANCAYA** – Permission to race in blinkers was given today as they were not shown in the race book.

INDIGO GIRLS - Slow to begin.

### RACE 9 - BULK NUTIENTS CLASS 1 HCP - (1430 METRES)

AFRICAN THUNDER - Raced wide throughout.

**BERSERKER** – Slow to begin.

**SWOOP THERE IT IS –** Held up home turn.

**NOBLE EXCEPTION** – Bounded on jumping and shifted out crowding MILLA"S READY.

**MILLA'S READY –** Crowded on jumping between NOBLE EXCEPTION and BESERKER. Raced wide throughout.
