Stewards spoke to trainer Mr M Pearce in relation to the racing manners of Straight Lines in particular approaching the winning post. Acting on their own observations, viewing the official replays and taking evidence from Mr Pearce. Stewards were of the opinion that Straight Lines when approaching the winning post, had turned its head outward and in doing so had failed to pursue the lure with due commitment throughout the event. Pursuant to GAR127(1)(a) Straight Lines has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial.
