Just Casper underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to trainer Mr E Howard in relation to Just Casper's racing manners, in particular rounding the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Howard, Stewards were of the opinion that Just Casper had turned its head outwards and had made head and muzzle contact with Lil Miss Meranda and by doing so had marred the running of that greyhound pursuant to GAR123(1). Acting under the provisions of GAR127(1)(a), Just Casper has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial. Replicant underwent a post-race veterinary examination which revealed spike wounds to both hocks. Replicant has been stood down from racing for a period of 2 days. Queen's Gamble underwent a post-race veterinary examination, and no injury could be detected. Buckle Up Hazel underwent a post-race veterinary examination, and no injury could be detected. Beginning from box 3, Summertime Sad completed the 278- metre trial distance in a time of 16.00. Summertime Sad has been cleared to race at Launceston only up to 278m.
