Trainer B Englund was fined the sum of \$100 under GAR 156(f)(ii) for negligence for failing to scratch Wynburn Elsa by the required time today. In arriving at this penalty stewards took into account his personal circumstances, his guilty plea and good record.

Trainer D Fitzsimmons was reprimanded under GAR 156 (f) (ii) for negligence for failing to organise a catcher in reasonable time prior to race 6.
