Buckle Up Zion which was marred after losing ground approaching the third turn underwent a post-race veterinary examination which initially revealed no injury. This greyhound was subsequently re-examined and was found to have mild soreness in the right wrist and right Tensor Fascia muscle and was stood down from racing for 10 days.

Hooked On Prissy was found guilty of marring the running of Buckle Up Zion approaching the third turn. As it was the greyhounds first offence under the provisions of GAR 123 the greyhound has been stood down from racing at Launceston only for 28 days and until the completion of a satisfactory trial pursuant to GAR 127(a).

GENERAL

LGRC 11 09 2023

Stewards concluded an inquiry into a kennel inspection of Trainer T Keogh's kennels on the July 12, 2023. Mr Keogh pleaded guilty to a charge under GAR 21 (c). The particulars of the charge being that as a licenced trainer with the Office Of Racing Integrity he failed to keep his kennels in a clean and sanitary condition. After submissions on penalty including his personal circumstances, his time in the industry and clean record under this rule and guilty plea, Mr Keogh was fined the sum of \$1000. \$500 of this is to be wholly suspended for two years unless he offends again under this rule

Mr Keogh also pleaded guilty to failing to maintain a treatment record for his greyhounds under GAR 151(1). After taking into account his submissions on penalty including his length of time in the industry and that it was his first offence, he was fined the sum of \$100.
