GENERAL

Licensed trainer S Croft pleaded guilty to a charge under GAR 156(f)(ii) for misconduct in that he swore in the catching pen after the running of race six where he was catching Son Of Neptune which had been marred in the home straight. After taking into

account his guilty plea and submissions on penalty he was fined \$200 which it to be wholly suspended for 12 months unless he offends again.

Licensed trainer H Pearce pleaded guilty to a charge under GAR 156(f)(ii) for misconduct in that she swore behind the starting boxes before the running of race ten where she was loading a greyhound . After taking into account his guilty plea and submissions on penalty she was fined \$100 which it to be wholly suspended for 12 months unless she offends again.
