RACE 1 – LABROKES PACE – 2180m Mobile

IMHOOKED – Broke gait racing into the first turn and again rounding the final turn, as a consequence, IMHOOKED was stood down from racing until satisfactorily completing one(1) qualifying trial.

SCARLET PLACE – Failed to secure clear running in the race to the finish.

MACARIA – Tended to over-race. Held up for clear running until well into the home straight in the run to the finish.

SCRUB BASHER – Inconvenienced when the pace eased and raced rough for a short distance near the 1900metres. Placed on its last chance to race truly after breaking gait free of interference early on the final turn.

RESUME NZ – Tired badly over the concluding stages, beaten in excess of 60 metres. Stewards deemed the performance below the required standard and stood RESUME NZ down from racing until satisfactorily completing one(1) qualifying trial. Stewards, in placing the embargo were mindful that RESUME NZ was placed on its last chance to race competitively at its most recent start.

General: Trainer B Yole was fined \$100 for failing to notify the change of head gear on DYNASTY STRIDE [AHR Rule 273(6)(b)].

RACE 2 – LIKE US ON FACEBOOK STAKES – 2180m Stand

TWO SOCK CREEK NZ – Galloped out at the start and continued to do so until well into the first turn. Consequently, TWO SOCK CREEK NZ will be excluded from the barrier draw in future standing start events.

SO ART I NZ – Stood flat footed and reared before moving away, badly missing the start being left behind approximately 150 metres, effectively taking no competitive part in the event and severely checking ALEXIS ROCKET NZ in the process. Consequently, SO ART I NZ will be excluded from the barrier draw in future standing start events.

MAJOR LESTER – Checked after the start when TWO SOCK CREEK NZ galloped out.

REBEL WITH A GRIN NZ – Checked after the start when TWO SOCK CREEK NZ galloped out.

ALEXIS ROCKET NZ – Severely checked after the start when SO ART I NZ galloped out.

COOL SCOOTER NZ – Will be reincluded in the barrier draw for races conducted under standing start conditions after satisfying ORI reinclusion requirements.

General: The 'all-clear' was delayed at the request of driver M Jones (NOVA BAXTER), so as he could review the official race footage of the start. On review, driver Jones had no objections, and as such, Stewards declared 'all-clear' on the judge's numbers 5-4-6-7-2.

RACE 3 – BIG 4 ULVERSTONE PACE – 2180m Mobile

LADY STRIDE – Began well to lead, raced rough on the first turn when being eased by its driver.

TIGERLICIOUS – Raced in a rearward marker peg position where it over-raced in the middle stages.

MAGIC JOE – Will be excluded from the barrier draw in mobile start events after breaking gait, free of interference, shortly after the start was effected.

GOING GREAT GUNS – Tired badly over the concluding stages, beaten in excess of 90 metres. Stewards deemed the performance below the required standard and stood GOING GREAT GUNS down from racing until satisfactorily completing one(1) qualifying trial. Stewards, in placing the embargo were mindful that GOING GREAT GUNS had tired significantly at its most recent start.

BONNY MY BOY – A post-race blood sample was taken for TCO2 analysis.

CEDRIC SEYMOUR – Raced rough at times.

RACE 4 – HARVEY NORMAN BURNIE PACE – 1680m Stand

SMOOTH DEAL NZ – Placed on its last chance in the draw for races conducted under standing start conditions after galloping out when the strands were released.

KARALTA DAZZLER – Checked and broke on the final turn.

SEA HAWKE – Galloped out, a warning was issued.

TERROR THE CHRISTIAN NZ – Checked and broke on the final turn.

FORBIDDEN JEWEL NZ – Checked and broke on the final turn.

JUNIPER - Galloped out, a warning was issued.

STYLISH TREND NZ – Inconvenienced after the start when SEA HAWKE galloped out. Checked and broke on the final turn.

CHRISTIAN JAZ NZ – Shifted in on the final turn.

MAYLEEJAE EAGLE – Broke gait when tightened and subsequently checked racing on the final turn.

General: Stewards inquired into the reason why MAYLEEJAE EAGLE broke gait midway through the final turn. Stewards, after taking evidence from drivers D Ford, (MAYLEEJAE EAGLE) and T Rattray, (CHRISTIAN JAZ NZ), particularly that tendered by driver Ford, took no action other than note the circumstances. During the inquiry driver Ford informed Stewards that there was clear room for him to take a run to the inside of CHRISTIAN JAZ NZ as it was racing in the one-out line along the back straight on the final occasion, despite the efforts of its driver as it was hanging out. However, on leaving the back straight after MAYLEEJAE EAGLE had been positioned to the inside of the sulky of CHRISTIAN JAZ NZ and on entering the final turn that gelding began to lay in, tightening the racing room of MAYLEEJAE EAGLE. Driver Rattray acknowledged that CHRISTIAN JAZ NZ had shifted in at the time, but was unable to ease the pressure to MAYLEEJAE EAGLE, as runners to his outside had followed his movement down closer to the markers.

RACE 5 – WYNYARD VETERINARY CLINIC PACE – 2180m Mobile

ONLY A MYTH – Placed on its last chance to race competitively after fading, giving ground over the final stages to be beaten in excess of 50 metres.

IDEAL KARALTA – Broke in the middle stages of the score-up, however was able to fill its allotted position at the start. Raced rough when wide over the final 900 metres where it hung in when under pressure.

LAID BACK KENNY – Will continue to be drawn on the extreme outside after failing to participate in the pre-race circle and out of position at the start.

RACE 6 – DOWLING MCCARTHY TYRES STAKES – 1892m Stand

ALBERIO – Declared a late scratching at 8:11pm, taken out by Stewards acting under Veterinary advice, when the gelding was found to be lame in the near-hind leg. ALBERIO will be ineligible to be nominated until connections forward on a Veterinary clearance to the offices of Racing Integrity. Due to the late scratching deductions of 19 cents in the win and 16 cents in the place were ordered on bets made prior to the announcement of the late scratching.

ALAPHILIPPE – Galloped out at the start and shifted wide checking AD MAIORA. Continued to gallop well into the first turn despite the efforts of its driver. Consequently, ALAPHILIPPE will be excluded from the barrier draw in future standing start events.

AD MAIORA – Checked after the start when ALAPHILIPPE shifted out, both shortly after the start and again approaching the first turn.

STALEY – Galloped out at the start. Consequently, STALEY will be excluded from the barrier draw in future standing start events. In assessing, Stewards were mindful that STALEY was placed on its last chance in the draw at its most recent Standing start event.

ROCK ON PLAYBOY– Inconvenienced after the start when ALAPHILIPPE galloped away and then checked entering the first turn as ALAPHILIPPE continued to gallop.

ONEOFTHELADS – Tended to hang out in the straights and in on the turns. A warning was issued.

SPOT ON NZ – Inconvenienced entering the first turn when ROCK ON PLAYBOY shifted wide to avoid the galloping ALAPHILIPPE.

RANIERI NZ – Momentarily tightened on the final turn when positioned between runners, this resulted in a minor contact between the front legs of RANIERI NZ and the sulky wheel of ONEOFTHELADS.

SLINGSHOT – Pulled up out of the event with approximately 1200 metres remaining after breaking gait due the hopple-shortener cord wrapping around its hind leg. The circumstances were noted. Trainer B Yole was instructed to take the necessary action to prevent a reoccurrence of this incident.

General: Stewards questioned driver T Yole into the reason why ONEOFTHELADS shifted ground on the final turn. Driver Yole stated that as ONEOFTHELADS had hung in on the turns during the event he was mindful of tightening WHATTA GOOD REASON, which was racing to his inside, and when checked away, his gelding over-reacted to his drive and shifted out. Driver Yole further stated that he was unable to return to his racing line as RANIERI NZ had quickly raced to his inside and he was obliged to refrain from shifting in as he had brushed the front legs of RANIERI NZ at the time.

General: Stewards delayed the 'all-clear' to review the start to confirm whether ALAPHILIPPE had gained an advantage whilst galloping. On review, Stewards were satisfied that no advantage was gained and as such declared 'all-clear' on the judge's numbers 9-5-2-3-6.

RACE 7 – LADBROKES HUB STAKES – 2200m Mobile

BLACKJACK JIM - Failed to secure clear running over the concluding stages.

General: Stewards questioned drivers T Yole (REMEMBER ME NOW NZ), T Ford (SMILE LYLE) and O Weidenbach, (CINOCAL JAMANE) into the reason why CINOCAL JAMANE raced four-wide approaching the 800 metres. At the inquiry, the evidence tendered by driver Weidenbach was that driver Yole had shifted wider with REMEMBER ME NOW NZ, well clear of CINOCAL JAMANE, however the momentum of her mare was to the point that she moved CINOCAL JAMANE out into the four-wide line, and then was then unable to return to the three-wide line as SMILE LYLE had taken up that position. Stewards although not fully convinced that this was the sole reason for CINOCAL JAMANE racing four-wide took no action other than to remind drivers, particularly driver Ford, of their obligations when shifting ground.

RACE 8 – BECOME A MEMBER STAKES – 2180m Stand

BRIAN WHO – Placed on its last chance in the draw in races conducted under standing start conditions after standing flat footed when the strands were released and then being slow to muster speed.

THE DUDE NZ – Will be excluded from the barrier draw in future races conducted under standing start conditions after breaking gait, free of interference, shortly after the start. Stewards noted DAPPER NZ was checked as a result of this incident.

JEDI MIND – Placed on its last chance in the draw in races conducted under standing start conditions after galloping away once the strands were released.

DAPPER NZ – Checked after the start when THE DUDE NZ broke gait.

LIFEOFBRIAN NZ – Fractious behind the barrier strands prior to the start.

SHANOCON NZ – Fractious behind the barrier strands prior to the start. Will continue to be excluded from the barrier draw in future races conducted under standing start conditions after standing flat footed when the strands were released and then being slow to muster speed.
