Comments / Explanations:

GENERAL

Rider B McCoull was indisposed for this meeting due to back soreness. Rider B McCoull was advised that a medical clearance would be required prior to him riding again.

Rider T Baker after being dislodged in Race 2 stood himself down due to stiffness to his shoulder. Rider T Baker was advised that a medical clearance would be required prior to riding again.

RACE 1 – PST POWER SOLUTIONS 2YO MAIDEN – (1000 Metres)

GET 'EM WARRIOR – Raced greenly throughout; ducked in abruptly rounding the home turn and had to be steadied off heels shortly after.

AZITKALA – Fractious when parading, slow to begin.

GEEGES MISTRUTH – Had a tendency to lay in throughout the home straight, ducked in abruptly near the 100 metres and had to be straightened. A warning has been placed on the filly's racing manners.

MS TASMANIA – Jumped awkwardly; severely checked near the 100 metres.

OLIVE GIRL – Laid in momentarily entering the home straight; badly hampered near the 100 metres and had to be steadied by its rider.

The trainer of the second placed OLIVE GIRL, Mr Stephen Shaw, viewed vision of the final stages with respect to potentially lodging an objection against race winner GEEGEES MISTRUTH, however elected not to proceed.

Stewards inquired into an incident near the 100 metres where rider B Muhcu (OLIVE GIRL) was hampered, and MS TASMANIA (T Baker) being checked. It was ascertained that GEEGES MISTRUTH (A Darmanin) tended to lay in in the home straight despite the efforts of its rider, near the 100 metres GEEGEES MISTRUTH shifted in abruptly when the whip was used on one occasion, resulting in OLIVE GIRL being hampered and MS TASMANIA being checked by its rider. Given all relative and contributing factors, including the greenness of GEEGEES MISTRUTH, and that rider Darmanin had immediately attempted to straighten his mount when it ducked in abruptly, no further action was required other than to advise Mr Darmanin to exercise care in when in similar circumstances, and in particular when riding out inexperienced 2YO's.

RACE 2 – PST POWER SOLUTIONS MAIDEN – (1100 Metres)

Apprentice Taylor Johnstone was dislodged enroute to the barriers. Ms Johnstone was uninjured.

Rider Troy Baker stood down from the remainder of the program after reporting some soreness following him being dislodged after the start.

SHOOTING NORTH – Laid in passing the 200 metres.

HELL TOFF – Shifted in shortly after the start.

LOYALTY BLUES – Dislodged rider enroute to the barrier.

GOLDEN SWEET HEART – Fractious when loaded away; commenced to buck shortly after leaving the barriers, dislodging rider Troy Baker, and continued riderless; stood-down one satisfactory trial. Veterinary examination revealed the mare to be mildly lame. The stable

veterinarian confirmed the following morning that the mare was lame in the off hind with mild abrasions also evident.

APRIL'S DANCE – Under-went a post-race veterinary examination and was found to have a high heart rate – slow recovery

MISS DE LUNE – Jumped awkwardly brushing the side of the barrier.

PEROLA – Over raced early stages, steadied off heels when attempting to improve to the inside of SHOOTING NORTH at about the 150 metres.

RIDE THE MOON – Difficult to load and fractious in the barriers. Trainer I Miller was advised that the filly must complete a satisfactory trial for fractious pre-race manners and being fractious in the barriers.

SH'BOURNE GLORY – Under-went a post-race veterinary examination and no abnormalities detected.

JAGGER ROCKS – Declared a late scratching at 8.40am due to no suitable rider being available.

Following the running of this event rider of the second placed PEROLA lodged an objection against the first placed SHOOTING NORTH alleging interference near the 150 metres. After consideration, the protest was dismissed.

RACE 3 – PST POWER SOLUTIONS MAIDEN/CLASS 1 – (2100 Metres)

BAVARIAN FLYER – Inconvenienced at the start when PENNINE jumped outwards. Rider A Darmanin advised stewards he placed the gelding under pressure from the 600 metres and it failed to respond to his riding. Gave ground latter stages – veterinary examination revealed no obvious abnormities. Trainer advised the gelding would now be retired.

GEEGEES SUNSHINE – Tired from the 200 metres.

KING KURT – Over-raced early stages.

PENNINE – Shifted out shortly after the start inconveniencing BAVARIAN FLYER, had to steady off heels of the tiring GEE GEES DESERT near the 500 metres.

GEE GEES DESERT – Gave ground from the 500 metres.

RACE 4 – PST POWER SOLUTIONS 0-60 – (1200 Metres)

Delay on correct weight for rider C Baker (GEE GEE GOLDENLASS) to view the official photo finish. After viewing correct weight was declared on the judge's numbers.

BETTER THAN BANKSY – Over-raced early and middles stages.

DING DING – Raced wide throughout.

BRINKTOP LAD – Held up at about the 500 metres and commenced to over race.

RACE 5 - MCKAY TIMBER CLASS 1 HANDICAP - (1200 Metres)

CARTOON GRAVEYARD – Raced wide throughout

FLYING BILLIE – Stewards granted permission for rider K Sanderson to ride 1/2kg over the allotted weight. Slow to muster early speed.

SPINHOF – Had to steady near the 100 metres when disappointed for a run, thereafter had to shift ground out to improve.

KINGS ON QUEENS – Slow to muster early speed.

NOBLE EXCEPTION – Slow to muster early speed.

KITTY PURRING – Raced wide throughout.

ZULU GURU – Underwent a post-race veterinary examination which revealed the mare to have suffered atrial fibrillation. ZULU GURU must not start in a race, official trial, or jump-out until the Stewards have received a satisfactory report from a qualified veterinary surgeon which includes the results of an electrocardiography (ECG) of more than 60 seconds duration performed by that veterinarian whilst the horse is at rest and a cardiac auscultation performed by that veterinarian within 15 minutes of the horse completing a satisfactory gallop of at least 1000 metres in the presence of a steward.

RACE 6 – PST POWER SOLUTIONS BM60 HANDICAP – (1400 Metres)

DIAMOND BAY – Declared a late scratching at 1.10pm on veterinary advice after being found to have nasal discharge when arriving on course. On the announcement of correct weight Stewards ordered that all monies invested on DIAMOND BAY be refunded, with the following deductions to apply to all successful wagers placed prior to 1.10pm.

Stewards ordered that the following deductions would apply:

1st – GLOBAL AWARENESS 2 cents win, 3 cents place 2nd – STEEL MIST 4 cents place 3rd – GODDESS OF ROCK 4 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

NICCO THE GREEK – Fractious in the barriers prior to the start.

SWING KING – Jumped outwards at the start.

JACKJACK – Raced wide throughout.

STEEL MIST – Raced wide throughout.

AMERICAN JEWEL – Gave ground latter stages – A post race veterinary examination revealed no obvious abnormalities.

AFRIDI (NZ) – Jumped awkwardly, laid in rounding the final turn.

RACE 7 – DERWENT PARK PLUMBING BM68 HANDICAP – (1100 Metres)

GEE GEE QUEEN BEE – Slow to begin.

TONY NICCONI – Gave ground passing 400 metres and finished well back, rider C Wells stated that in her opinion the field raced too hard too early for the gelding when leading the event. A post-race veterinary examination revealed no abnormalities.

MAKE A DECISION - Slow to begin.

THUNBERG – Raced wide throughout.

ZEWINNA – Jumped awkwardly, slow to begin.

RACE 8 - ROTARY CLUB OF GLENORCHY BM68 HANDICAP - (1600 Metres)

FREAK ON A LEAD – Over-raced in the early stages.

CHI MAZEL – Bumped with BLUSHED at the start.

SUNSET GUN – Bumped at start; raced wide throughout.

BLUSHED – Bumped with CHI MAZEL at the start.

ZULU ANGEL – Slow to begin, raced wide throughout

DOONICAN – Slow to begin
