Blackpool Darren underwent a post-race veterinary examination which detected a moderate tear to the right triceps. Blackpool Darren has been stood down from racing for 21 days. Stewards spoke to trainer Glenn Howlett in relation to Blackpool Darren's race manners approaching the winning post. After viewing the official replays, Stewards were of the opinion that Blackpool Darren had breached GAR123 for marring, in making head and muzzle contact with Super Suspect. Acting under the provisions of GAR127(c), Blackpool Darren has been stood down from racing for a period of three months, and until the competition of two satisfactory trials.
