Stewards spoke to trainer representative Ian Thomas regarding Zipping Mariah's race manners in the home straight. After viewing the official replays, Stewards were of the opinion that Zipping Mariah had breached GAR124 in turning its head outwards towards Aquiline Nose, and in doing so, failed to pursue the lure. Acting under the provisions of GAR127(a), Zipping Mariah has been stood down from racing for a period of 28 days at Hobart only, and until the competition of a satisfactory trial.

#### **GENERAL**

Super Shanks completed a steward's satisfactory trial over 461 metres for marring under GAR 123 at Hobart on the 9<sup>th</sup> January 2024. Beginning from box 5 and weighing 31.8kg, Super Shanks completed the distance in a time of 26.02 has been cleared to race at all tracks.
