Hooked On Prissy completed a steward's satisfactory trial for marring over 278 metres. Weighing 29.4 kilograms and starting from box 3 with 3 other greyhounds the greyhound completed the event in a time of 16.29 and ran a time of 16.29. This greyhound has been cleared to race all tracks.

Lost Magic completed a steward's satisfactory trial for failing to pursue over 278 metres. Weighing 28.1 kilograms and starting from box 5 with 4 other greyhounds the greyhound completed the event in a time of 16.26. This greyhound has been cleared to race all tracks up to 340 metres.

Borderline Bella completed a steward's satisfactory trial for failing to pursue by reason of injury over 278 metres. Weighing 27.3 kilograms and starting from box 3 with 3 other greyhounds the greyhound completed the event in a time of 16.64. This greyhound has been cleared to race all tracks up to 340 metres. Borderline Bella underwent a post-race veterinary examination, and the greyhound was found to have a superficial graze to the right lateral forearm and has been stood down from racing for 5 days.
