GENERAL

Due to the high temperatures recorded across the state, additional measures were implemented to ensure the welfare of all greyhounds was monitored upon arrival at the venue and throughout the race meeting. Kennelling time was extended to 75 minutes to allow greyhounds to be kennelled as soon as they arrived at the venue. Three Veterinarians were engaged for the event, with all greyhounds undergoing additional veterinary examinations to ensure they were not suffering from dehydration or heat stress. Ice baths were provided to assist with cooling greyhounds prior to kennelling and throughout the race meeting. The internal temperature of the kennel block was 16° upon the commencement of kennelling and remained at this temperature throughout the duration of the meeting. All greyhounds were required to return to the kennel area for at least 30 minutes post racing to allow sufficient time to cool off prior to being transported.

Wellington Chaos completed a Stewards satisfactory weight trial. Weighing 33.3 kilograms and beginning from box 3, completed the 340m trial in a time of 19.95. Wellington Chaos was unsatisfactory after easing in the home straight and failing to pursue the lure with due commitment. Wellington Chaos underwent a post-race veterinary examination which detected soreness in the lumbar muscles. Wellington Chaos has been stood down from racing (trailing) for 5 days.
