Evacuate underwent a post-race veterinary examination, which detected small lacerations to the left fore foot, left hind foot and a minor abrasion above the hock on the left hind leg, however no stand down period was applied. Stewards spoke to trainer Patrick Hall regarding Evacuate's race manners when entering the home straight. After viewing the official replays, Stewards were of the opinion that Evacuate had breached GAR124 in turning its head outwards, and in doing do, the greyhound failed to pursue the lure. Acting under the provisions of GAR127(a), Evacuate has been stood down from racing for a period of 28 days at Hobart only, and until the completion of a satisfactory trial. A post-race swab sample was taken from Burn And Run.
