Wynburn Honey underwent a post-race veterinary examination which detected abraded to the webbing on the left hind leg, no stand down period was applied. Stewards spoke to trainer Ben Englund regarding Wynburn Honey's race manners when approaching the finish line. After viewing the official replays, Stewards were of the opinion that Wynburn Honey had breached GAR124 in turning its head outwards, and in doing do, the greyhound failed to pursue the lure. Acting under the provisions of GAR127(a), Wynburn Honey has been stood down from racing for a period of 28 days at Hobart only, and until the completion of a satisfactory trial.

## **GENERAL**

The start of kennelling was due to traffic congestion in and around Hobart. Dr. Geoff Baxter commenced kennelling at 6:26pm and continued until rostered Vet Dr. Felicity Voigt arrived at 6:45pm.

Evacuate completed a Stewards satisfactory trial over 461 metres pursuant to GAR124, for failing to pursue in Hobart on the 7th March 2024. Weighing 28.5kg and beginning from box 3, Evacuate completed the trial in 26.58 and is cleared to race all tracks.

Can't Say completed a Stewards satisfactory trial over 340 metres pursuant to GAR135, as the greyhound had not raced for a period of six months. Weighing 26.9kg and beginning from box 3, Can't Say completed the trial in 19.63 seconds and is cleared to race all tracks.

Flaming Flirt completed a Stewards satisfactory trial over 340 metres pursuant to GAR123 for marring in Launceston on the 12<sup>th</sup> February 2024. Weighing 34.7kg and beginning from box 3, Flaming Flirt completed the trial in 19.83 seconds and is cleared to race all tracks except Launceston.
