Kellatier King underwent a post-race veterinary examination which detected thumps and an abrasion to the left hind foot, no stand down period was applied. Stewards spoke to trainer Glenn Howlett via telephone regarding Kellatier King's race manners in the home straight. After viewing the official replays, Stewards were of the opinion that Kellatier King had breached GAR123 in turning its head inwards and making head and muzzle contact with Furry Potter. Acting under the provisions of GAR127(a), Kellatier King has been stood down from racing for a period of 28 days at Hobart only, and until the completion of a satisfactory trial. A post-race swab sample was taken from Kirwan.
