## STEWARDS INQUIRY DECISION

Stewards Panel: T. Canham (Chairman) and E. Morice-Smith

Stewards inquired into the conduct of licenced trainer Glenn Howlett towards officiating Veterinarian Dr. Felicity Voigt at the HGRC meet on Thursday 11<sup>th</sup> April 2024.

Stewards heard evidence/received statements from Mr Dominic Tyson and Mr Robert Simpson who were present during the incident, and evidence from Mr Glenn Howlett.

After hearing the evidence presented, Stewards issued a charge to Mr Howlett pursuant to GAR156(g)(iv) An offence is committed if a person (including an official) wilfully assaults, obstructs, impedes, abuses, interferes with, threatens or insults a Steward or any other official of a Controlling Body or a Club.

Stewards believe Mr Howlett insulted Dr Voigt during kennelling on the 11<sup>th</sup> April 2024 when he raised his voice while questioning Dr Voigt's professional opinion and calling her incompetent, and the language (swearing) he used when exiting the kennel area.

In determining penalty, Stewards took into consideration Mr Howlett's honesty and conduct throughout the inquiry, his record which shows no prior misconduct charges and the remorse shown by Mr Howlett regarding his conduct. However, Stewards view Mr Howlett's conduct towards Dr Voigt as serious, and that any penalty issued should act as a deterrent for this type of behaviour from licenced participants in this matter and in future.

Stewards suspended Mr Howlett's licence for a period of three months. This penalty is to be wholly suspended for a period of 24 months pending no further breaches of the rules regarding conduct.
