After viewing the official replays, Stewards were of the opinion that Flaming Flirt had breached GAR124 in turning its head inwards, and in doing so, the greyhound failed to pursue the lure. Acting under the provisions of GAR125(1)(a), Flaming Flirt has been stood down from racing for a period of 12 days and until the completion of a satisfactory trial.
