Wynburn Honey completed a Stewards satisfactory trial for failing to pursue pursuant to GAR 124. Weighing 29.6 kg and competing over 461m and beginning from box 3 with two other greyhounds the greyhound ran 1<sup>st</sup> a time of 26.37 and has been cleared to race at all tracks.

Buzz The Hustler completed a Stewards satisfactory trial for marring pursuant to GAR 124. Weighing 31.5 kg and competing over 461m and beginning from box 3 with three other greyhounds the greyhound ran 1<sup>st</sup> a time of 26.66 and has been cleared to race at all tracks except Angle Park.
