GENERAL

Colden Mandella completed a Stewards satisfactory trial over 340 metres pursuant to GAR135 as the greyhound had not raced for more than 6 months. Weighing 33.1kg and beginning from box 3, Colden Mandella completed the trial in 19.45 seconds and is cleared to race all tracks.

Faster Than Nan completed a Stewards satisfactory trial over 461 metres pursuant to GAR124, as the greyhound was stood down from racing for failing to pursue in Launceston on the 25th March 2024. Weighing 25.5kg and beginning from box 3, Faster Than Nan completed the trial in 27.46 seconds. Faster Than Nan has not been cleared to race as the greyhound eased in running in the back straight and finished outside of the qualifying time.
