After viewing the official replays, Stewards were of the opinion that Wynburn Honey had breached GAR123 for marring, in making head and muzzle contact with Buckle Up Majel. Acting under the provisions of GAR127(a) for a first offence, Wynburn Honey has been suspended from racing at Launceston only for 28 days and until the completion of a satisfactory trial.
